INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, MARCH 22, 2017

A RESOLUTION

- 1 Recognizing March 30, 2017, as "Welcome Home Vietnam Veterans Day" in Pennsylvania.
- 3 WHEREAS, The Vietnam Conflict was fought in Vietnam from 1961
- 4 to 1975, and it involved North Vietnam and the Viet Cong in
- 5 conflict with the United States and South Vietnam; and
- 6 WHEREAS, The United States became involved in the Vietnam
- 7 Conflict because policymakers in the United States believed that
- 8 if South Vietnam fell to a communist government then communism
- 9 would spread throughout the rest of Southeast Asia; and
- 10 WHEREAS, Members of the United States Armed Forces began
- 11 serving in an advisory role to South Vietnam in 1961; and
- 12 WHEREAS, As a result of the Gulf of Tonkin incidents on
- 13 August 2 and 4, 1964, the Congress of the United States
- 14 overwhelmingly passed the Gulf of Tonkin Resolution (Public Law
- 15 88-408) on August 7, 1964, which effectively handed over war-

- 1 making powers to President Lyndon B. Johnson until such time as
- 2 peace and security had returned to Vietnam; and
- 3 WHEREAS, In 1965, United States Armed Forces ground combat
- 4 units arrived in Vietnam; and
- 5 WHEREAS, By the end of 1965, there were 80,000 United States
- 6 troops in Vietnam and, by 1969, a peak of approximately 543,000
- 7 troops was reached; and
- 8 WHEREAS, On January 27, 1973, the Paris Peace Accords were
- 9 signed, which required the release of all United States
- 10 prisoners of war held in North Vietnam and the withdrawal of all
- 11 United States Armed Forces from South Vietnam; and
- 12 WHEREAS, On March 30, 1973, the United States Armed Forces
- 13 completed the withdrawal of combat troops from Vietnam; and
- 14 WHEREAS, More than 58,000 members of the United States Armed
- 15 Forces lost their lives in Vietnam, and more than 300,000
- 16 members were wounded; and
- 17 WHEREAS, In 1982, the Vietnam Veterans Memorial was dedicated
- 18 in the District of Columbia to commemorate those members of the
- 19 United States Armed Forces who died or were declared missing in
- 20 action in Vietnam; and
- 21 WHEREAS, The Vietnam Conflict was an extremely divisive issue
- 22 among the people of the United States; and
- 23 WHEREAS, Members of the United States Armed Forces who served
- 24 bravely and faithfully for the United States during the Vietnam
- 25 Conflict were caught upon their return home in the crossfire of
- 26 public debate about the involvement of the United States in the
- 27 Vietnam Conflict; and
- 28 WHEREAS, The establishment of "Welcome Home Vietnam Veterans
- 29 Day" would be an appropriate way to honor those members of the
- 30 United States Armed Forces who served in Vietnam during the

- 1 Vietnam Conflict; therefore be it
- 2 RESOLVED, That the House of Representatives recognize and
- 3 proclaim March 30, 2017, as "Welcome Home Vietnam Veterans Day"
- 4 in Pennsylvania.
