INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, APRIL 24, 2017

A RESOLUTION

1 2	Designating May 9, 2017, as "Pennsylvania Health Care Information Technology Awareness Day" in Pennsylvania.
3	WHEREAS, According to the Centers for Medicare and Medicaid
4	Services, in 2015 United States health care spending grew 5.8%,
5	reaching \$3.2 trillion or \$9,990 per person; and
6	WHEREAS, As a share of the nation's gross domestic product,
7	health care spending accounted for 17.8% in 2015; and
8	WHEREAS, Health care spending has risen more than 40% in the
9	last decade; and
10	WHEREAS, The health care industry invests only 5% of its
11	revenue on information technology and management systems versus
12	10.5% of other data-intensive industries, such as banking; and
13	WHEREAS, A recent study by the Commonwealth Fund has
14	demonstrated that the use of automated clinical decision support
15	systems can result in a net reduction of \$538 per patient per
16	hospital stay; and

1 WHEREAS, The Institute of Medicine reports that there are at 2 least 1.5 million preventable adverse drug events per year, each 3 adding more than \$8,700 to the cost of a hospital stay; and WHEREAS, The Centers for Medicare and Medicaid Services 4 reports that, between 2011 and 2015, 50,607 providers and 5 facilities in Pennsylvania received \$1.4 billion in Federal 6 7 incentive payments to implement electronic health care records; 8 and

9 WHEREAS, Ninety-seven percent of eligible hospitals and 56% 10 of ambulatory health care providers in Pennsylvania have 11 adopted, upgraded or demonstrated meaningful use of an 12 electronic health care record system in 2015; and 13 WHEREAS, Health care providers in this Commonwealth report an 14 improved ability to recruit physicians coming out of medical 15 school when advanced information technology is deployed at their 16 sites; and

17 WHEREAS, Supporters and members of the Healthcare Information18 and Management Systems Society advocate for the following:

19 (1) Improved access to health care for rural20 Pennsylvanians through the expanded use of telehealth.

(2) Funding for work force development programs to help
increase the health care and information technology work
force in this Commonwealth.

24 (3) The adoption of policies that promote

25 interoperability standards which enable cooperation by all

26 provider communities in this Commonwealth;

28 RESOLVED, That the House of Representatives designate May 9, 29 2017, as "Pennsylvania Health Care Information Technology 30 Awareness Day" in Pennsylvania; and be it further
