INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, JUNE 5, 2015

A RESOLUTION

- Designating June 5, 2015, as "PA Sustainable Forestry Initiative Day" in Pennsylvania.
- 3 WHEREAS, In October 1994, the American Forest & Paper
- 4 Association (AF&PA) announced a landmark program for its
- 5 membership, the Sustainable Forestry Initiative (SFI); and
- 6 WHEREAS, The Pennsylvania SFI Implementation Committee (SIC)
- 7 was formed in 1995 and began meeting monthly in State College;
- 8 and
- 9 WHEREAS, It was quickly decided that the Hardwood Lumber
- 10 Manufacturers Association of Pennsylvania, which is now the
- 11 Pennsylvania Forest Products Association, would house and
- 12 provide administrative support to the newly formed SIC; and
- 13 WHEREAS, The guidelines required that AF&PA members practice
- 14 sustainable forestry on their own lands and educate loggers and
- 15 nonindustrial landowners on sustainable forestry; and
- 16 WHEREAS, Given that the majority of private forestland in

- 1 this Commonwealth is owned by more than one-half million
- 2 nonindustrial private forest landowners, it was a challenge to
- 3 develop the SFI program; and
- 4 WHEREAS, The early focus of the SIC was the establishment of
- 5 a logger training program, educational outreach to landowners
- 6 and the public and the development of a Best Management
- 7 Practices (BMP) monitoring system for measuring success; and
- 8 WHEREAS, More than 7,000 individuals have participated in the
- 9 logger program over the last 20 years, with approximately 700
- 10 participants maintaining a current training status each year and
- 11 some loggers having completed more than 100 hours of total
- 12 training; and
- 13 WHEREAS, Over 26,000 landowner outreach packets have been
- 14 distributed, and the information in the outreach packets is
- 15 accessible to a wider audience through the SFI website; and
- 16 WHEREAS, The benefits of the training program were further
- 17 recognized and bolstered when the Bureau of Forestry adopted a
- 18 policy in 2007 that required all commercial timber harvesting
- 19 activities on the Commonwealth's 2.2 million acres of forestland
- 20 to be led by an SFI trained logger; and
- 21 WHEREAS, More recently, the Pennsylvania Game Commission has
- 22 also recognized the benefits of the training program and
- 23 encourages its loggers to also participate; and
- 24 WHEREAS, People of all ages and backgrounds from across the
- 25 United States and Canada came together last month to break the
- 26 Guinness World Record for the most trees planted in one hour by
- 27 small teams; and
- WHEREAS, Organized by the national SFI, more than 200,000
- 29 trees were planted simultaneously in 28 different communities.
- 30 Two groups of representatives from industry, the Pennsylvania

- 1 Bureau of Forestry and other groups were part of the
- 2 Pennsylvania effort, which included 45 planters and 3,957 trees
- 3 planted in the Moshannon State Forest and 56 planters and 3,366
- 4 trees planted in the Tuscarora State Forest; therefore be it
- 5 RESOLVED, That the House of Representatives designate June 5,
- 6 2015, as "PA Sustainable Forestry Initiative Day" in
- 7 Pennsylvania.
