A RESOLUTION

- Recognizing the bravery and professionalism of the Philadelphia Police Department during the events of August 14, 2019.
- 3 WHEREAS, On the afternoon of August 14, 2019, police officers
- 4 from the 39th District of the City of Philadelphia were
- 5 attempting to serve a narcotics warrant in the Nicetown area;
- 6 and
- 7 WHEREAS, In the process of serving this warrant, police
- 8 officers came under fire; and
- 9 WHEREAS, Police officers from the 14th, 25th, 35th and 39th
- 10 Districts, along with police officers from the Narcotics Strike
- 11 Force responded to the call and worked to protect the people in
- 12 the area and apprehend the suspect; and
- 13 WHEREAS, Police Officer Joshua Burkitt, a 2-year veteran
- 14 assigned to the 24th District, sustained a gunshot wound to the

- 1 left hand; and
- 2 WHEREAS, Police Officer Michael Guinter, a 12-year veteran
- 3 assigned to the Narcotics Strike Force, sustained gunshot wounds
- 4 to both arms; and
- 5 WHEREAS, Police Officer Shaun Parker, an 11-year veteran
- 6 assigned to the Narcotics Strike Force, sustained a graze wound
- 7 to the head; and
- 8 WHEREAS, Police Officer Nathaniel Harper, a 19-year veteran
- 9 assigned to the Narcotics Strike Force, sustained a gunshot
- 10 wound to the left leg; and
- 11 WHEREAS, Police Officer Ryan Waltman, a 12-year veteran
- 12 assigned to the 39th District, sustained a gunshot wound to the
- 13 right hand; and
- 14 WHEREAS, Police Officer Justin Matthews, a 3-year veteran
- 15 assigned to the 16th District, sustained a graze wound to the
- 16 left leg; and
- 17 WHEREAS, The police were successful in avoiding any civilian
- 18 casualties; and
- 19 WHEREAS, The police officers were able to successfully
- 20 evacuate several day care facilities that were operating in the
- 21 vicinity of the stand-off; and
- 22 WHEREAS, After a nearly eight hour stand-off, including
- 23 numerous negotiation attempts, the police used tear gas to force
- 24 the suspect out of the home; and
- 25 WHEREAS, The police were able to apprehend the suspect
- 26 without injuring him; therefore be it
- 27 RESOLVED, That the House of Representatives recognize the
- 28 bravery and professionalism of the Philadelphia Police
- 29 Department during the events of August 14, 2019; and be it
- 30 further

- 2 of all officers involved; and be it further
