A RESOLUTION

- Recognizing April 2014 as "Parkinson's Disease Awareness Month" in Pennsylvania. 2
- WHEREAS, Parkinson's disease impacts one million people in 3
- the United States and is expected to rise parallel with
- increasing life expectancy with projections estimated to double
- the prevalence by 2030; and
- 7 WHEREAS, Parkinson's disease is the second most common
- progressive neurodegenerative condition in the United States; 8
- and
- 10 WHEREAS, Although research suggests the cause of Parkinson's
- 11 disease is a combination of genetic and environmental factors,
- the exact cause of the progression of the disease is still 12
- 13 unknown; and

- 1 WHEREAS, Symptoms of Parkinson's disease vary from person to
- 2 person and include tremors, rigidity, difficulty with balance,
- 3 swallowing and speaking, cognitive problems, dementia, mood
- 4 disorders, such as depression and anxiety, and sleep
- 5 disruptions, all of which can significantly affect the patient's
- 6 daily activities and motor function; and
- 7 WHEREAS, Life expectancy is reduced for all onset ages, with
- 8 disease progression leading to severe disability and possible
- 9 confinement to a wheelchair or bed; and
- 10 WHEREAS, Although treatments are initially effective in
- 11 treating symptoms, 50% to 90% of patients develop motor
- 12 complications, such as "wearing-off," early-morning akinesia,
- 13 delayed response, suboptimal response or no response, freezing
- 14 episodes and dyskinesia; and
- 15 WHEREAS, There is no cure, therapy or drug to halt the
- 16 progression of Parkinson's disease; and
- 17 WHEREAS, The National Parkinson Foundation, the Parkinson's
- 18 Action Network and the Parkinson's Disease Foundation are
- 19 nonprofit organizations; and
- 20 WHEREAS, The National Parkinson Foundation, the Parkinson's
- 21 Action Network and the Parkinson's Disease Foundation have
- 22 joined together to promote Parkinson's disease awareness and
- 23 support programs to improve education, knowledge, research and
- 24 treatment of the condition; and
- 25 WHEREAS, The National Parkinson Foundation, the Parkinson's
- 26 Action Network and the Parkinson's Disease Foundation are urging
- 27 patients and their supporters, health care providers and the
- 28 general public to demonstrate that they care by sharing the road
- 29 patients walk, the facts about Parkinson's disease and ever-
- 30 growing awareness about the etiology of this disorder and

- 1 potential treatment; and
- 2 WHEREAS, The community's focus on Parkinson's disease and its
- 3 impact on patients' lives will help give hope for a better
- 4 future for people with Parkinson's disease; and
- 5 WHEREAS, Increased awareness and expanded knowledge of the
- 6 realities of life with Parkinson's disease are needed to help
- 7 find more effective treatments or a cure for Parkinson's
- 8 disease; therefore be it
- 9 RESOLVED, That the House of Representatives recognize the
- 10 month of April 2014 as "Parkinson's Disease Awareness Month" in
- 11 Pennsylvania and urge all of our citizens to support the search
- 12 for a cure and assist those individuals and families who deal
- 13 with this disabling disease on a daily basis.
