A RESOLUTION

- Designating the week of April 8 through 14, 2018, as "Crime Victims' Rights Week" in Pennsylvania.
- 3 WHEREAS, Americans are the victims of 20 million crimes each
- 4 year, affecting individuals and communities; and
- 5 WHEREAS, The millions of survivors of crime and their
- 6 families are no less deserving of justice, rights, resources,
- 7 restoration and rehabilitation than the violent offenders who
- 8 victimize them; and
- 9 WHEREAS, Americans recognize that we make our homes,
- 10 neighborhoods and communities safer and stronger by serving
- 11 victims of crime and ensuring justice for all; and
- 12 WHEREAS, Crime victims play an indispensable role in bringing
- 13 offenders to justice; and
- 14 WHEREAS, In the United States Department of Justice, the
- 15 Office for Victims of Crime (OVC) was established to enhance the

- 1 capacity to assist crime victims and promote justice and healing
- 2 for all victims of crimes; and
- 3 WHEREAS, Over the past three decades, crime victims and their
- 4 advocates have made unparalleled progress toward balancing the
- 5 scales of justice in the criminal justice system; and
- 6 WHEREAS, For many years, the OVC has helped lead communities
- 7 throughout this nation in its observance of "National Crime
- 8 Victims' Rights Week" to bolster public awareness about the
- 9 challenges crime victims face and to celebrate the hard-won
- 10 progress in victims' rights and services; and
- 11 WHEREAS, Victim service providers, criminal justice officials
- 12 and concerned citizens throughout this nation are joining
- 13 together to observe "National Crime Victims' Rights Week"; and
- 14 WHEREAS, The theme for this year's "National Crime Victims'
- 15 Rights Week" is "Expand the Circle: Reach All Victims.";
- 16 therefore be it
- 17 RESOLVED, That the House of Representatives designate the
- 18 week of April 8 through 14, 2018, as "Crime Victims' Rights
- 19 Week" in Pennsylvania; and be it further
- 20 RESOLVED, That the House of Representatives reaffirm its
- 21 commitment to address victims' rights and criminal justice
- 22 issues.
