INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, APRIL 6, 2016

A RESOLUTION

- Recognizing the week of April 17 through 23, 2016, as "Shaken Baby Syndrome Awareness Week" in Pennsylvania.
- 3 WHEREAS, The well-being of this generation and future
- 4 generations depends in great measure upon the ability and
- 5 dedication of those who devote themselves to make the safety,
- 6 welfare and well-being of our precious children their highest
- 7 priority; and
- 8 WHEREAS, In 2012, statistics show that 680,000 children were
- 9 victims of abuse and neglect in the United States and according
- 10 to the Department of Human Services this number includes 3,565
- 11 children in this Commonwealth; and
- 12 WHEREAS, On average, between four and seven children will die
- 13 every day as the result of abuse or neglect in the United
- 14 States; and

- 1 WHEREAS, The leading cause of death and disability among
- 2 abused children under five years of age is infant abusive head
- 3 trauma, including the inflicted trauma known as shaken baby
- 4 syndrome; and
- 5 WHEREAS, Shaken baby syndrome is one of the most severe forms
- 6 of child abuse caused by the violent shaking of an infant with
- 7 or without impact against an object; and
- 8 WHEREAS, Shaken baby syndrome and other inflicted head
- 9 traumas occur when a caregiver loses control and shakes a baby
- 10 or young child, most frequently less than one year of age, but
- 11 in some cases as old as five years of age, resulting in
- 12 blindness, broken bones, cerebral palsy, brain damage, hearing
- 13 loss, paralysis, seizures, mental retardation, speech or
- 14 learning difficulties and death; and
- 15 WHEREAS, Such abuse causes unspeakable pain and suffering to
- 16 our most vulnerable residents, while putting enormous strain on
- 17 families in all communities; and
- 18 WHEREAS, On average across the United States, 750 to 3,750
- 19 infants and young children are diagnosed with shaken baby
- 20 syndrome every year, with medical experts believing that
- 21 thousands of additional cases are misdiagnosed or undetected;
- 22 and
- 23 WHEREAS, Approximately one-third of the victims die as a
- 24 result of direct brain injuries; and
- 25 WHEREAS, Even in milder cases in which babies look normal
- 26 immediately after the shaking, the child may eventually develop
- 27 irreversible damage due to the child's injuries; and
- 28 WHEREAS, The most effective way to end shaken baby syndrome
- 29 is by preventing such abuse and it is clear that minimal costs
- 30 of educational and preventive programs may avert enormous

- 1 medical and disability costs and immeasurable grief for many
- 2 families; and
- 3 WHEREAS, Hospital-based education programs, such as the
- 4 nationally recognized Shaken Baby Syndrome Prevention &
- 5 Awareness Program developed by Dr. Mark Dias of the Penn State
- 6 Hershey Medical Center, provide critically important information
- 7 about shaken baby syndrome to every parent of every child born
- 8 in this Commonwealth; and
- 9 WHEREAS, In 2002, the Shaken Baby Syndrome Education Act was
- 10 enacted, establishing the Shaken Baby Syndrome Education and
- 11 Prevention Program; and
- 12 WHEREAS, The Shaken Baby Syndrome Education and Prevention
- 13 Program partnered with the Department of Health, and in 2006,
- 14 Pennsylvania became the first state in the nation to provide
- 15 consistent hospital-based education in 100% of all birthing and
- 16 children's hospitals in this Commonwealth; and
- 17 WHEREAS, Prevention and awareness efforts are supported by
- 18 national and local organizations, such as the Department of
- 19 Health, the Brain Injury Association of Pennsylvania, the
- 20 Centers for Disease Control and Prevention, the American Academy
- 21 of Pediatrics, Prevent Child Abuse Pennsylvania, the Cynthia
- 22 Gibbs Foundation, the Skipper Initiative, the National Center on
- 23 Shaken Baby Syndrome, the Children's Defense Fund, the Child
- 24 Welfare League, the Shaken Baby Alliance and the Pennsylvania
- 25 Family Support Alliance, that all work to educate new parents
- 26 and caregivers and increase awareness among the general public
- 27 to encourage increased support for victims and their families in
- 28 the health care and criminal justice systems; and
- 29 WHEREAS, Prevention and awareness has been shown to provide
- 30 critically important information about shaken baby syndrome to

- 1 parents, caregivers, day-care workers, child protection
- 2 employees, law enforcement personnel, health care professionals,
- 3 the general public and representatives of the justice system;
- 4 therefore be it
- 5 RESOLVED, That the House of Representatives recognize the
- 6 week of April 17 through 23, 2016, as "Shaken Baby Syndrome
- 7 Awareness Week" in Pennsylvania and encourage all residents to
- 8 observe this week with programs and activities that share the
- 9 commitment of prevention, awareness, community support and
- 10 partnerships to protect our children from shaken baby syndrome;
- 11 and be it further
- 12 RESOLVED, That the House of Representatives commend those
- 13 advocates, organizations and agencies of national, State, county
- 14 and local governments that work continuously to educate parents,
- 15 caregivers and professionals about the causes, consequences and
- 16 prevention of shaken baby syndrome and other inflicted head
- 17 injuries.
