1 2 3	Amending House Rule 32, further providing for hospital and home appropriations, acquiring lands of the Commonwealth and congressional redistricting.
4	RESOLVED, That House Rule 32 be amended to read:
5	RULE 32
6	Hospital and Home Appropriations,
7	Acquiring Lands of the Commonwealth
8	and Congressional Redistricting
9	No bills appropriating moneys to State-aided hospitals or
10	State-aided homes shall be introduced in the House, except such
11	as appropriate in single bills the total sum to be appropriated
12	to all of the institutions within the same class or group.
13	Requests for appropriations for particular State-aided hospitals
14	or State-aided homes shall be filed with the Chair of the
15	Committee on Appropriations on forms to be furnished by the said
16	Committee on Appropriations, and shall be signed by the member
17	requesting the appropriation.
18	No bill granting or conveying Commonwealth lands or taking

- 1 title thereto shall be reported by any committee to the House,
- 2 nor shall an amendment making substantive changes to such a bill
- 3 be offered on the floor of the House, unless there has been
- 4 filed with the Chief Clerk, the Legislative Data Processing
- 5 <u>Center</u> and the chair of the reporting committee a memorandum
- 6 from the Department of General Services indicating the use to
- 7 which the property is presently employed, the full consideration
- 8 for the transfer, if any, a departmental appraisal of the
- 9 property, including its valuation and a list of recorded liens
- 10 and encumbrances, if any, the use to which the property will be
- 11 employed upon its transfer, the date by which the land is needed
- 12 for its new use, and the legislative district or districts in
- 13 which the land is located. The memorandum shall contain a
- 14 statement by a responsible person in the Department of General
- 15 Services indicating whether or not the administration favors the
- 16 transfer which is the subject of the bill under consideration.
- 17 The memorandum shall be posted by the Legislative Data
- 18 Processing Center on the publicly accessible Internet website of
- 19 the General Assembly.
- No bill proposing the redistricting of congressional
- 21 districts shall be reported by any committee to the House, nor
- 22 shall an amendment making substantive changes be offered on the
- 23 floor of the House, unless such bill or amendment is accompanied
- 24 by a map showing the proposed congressional districts. Any such
- 25 bill or amendment, along with the accompanying map, shall be
- 26 posted by the Legislative Data Processing Center on a publicly
- 27 accessible Internet website of the General Assembly.
