INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, MAY 5, 2014

A RESOLUTION

- Designating Wednesday, May 7, 2014, as "Pennsylvania Health Care Information Technology Awareness Day."
- 3 WHEREAS, Health care costs represent 17.2% of Gross Domestic
- 4 Product (GDP) nationally; and
- 5 WHEREAS, Seventy percent of health care transactions are
- 6 paper based; and
- 7 WHEREAS, The health care industry invests only 5% of revenue
- 8 on information technology and management systems versus 10.5% of
- 9 other data-intensive industries such as banking; and
- 10 WHEREAS, The United States spends more than \$2.8 trillion on
- 11 health care a year, yet some of that spending is unnecessary and
- 12 spent on clinical and administrative waste, theft and excess
- 13 costs; and
- 14 WHEREAS, Spending on health care has risen over 40% in the
- 15 last decade; and

- 1 WHEREAS, In Pennsylvania, medical assistance/Medicaid
- 2 spending in 2013 was \$20.3 billion; and
- 3 WHEREAS, A study by the Commonwealth Fund has demonstrated
- 4 that the use of automated clinical decision support systems can
- 5 result in the net reduction of \$538 per patient per hospital
- 6 stay; and
- 7 WHEREAS, The Institute of Medicine reports there are at least
- 8 1.5 million preventable adverse drug events per year, each
- 9 adding more than \$8,700 to the cost of a hospital stay; and
- 10 WHEREAS, The Centers for Medicare and Medicaid Services
- 11 reports that between 2011 and 2013, 14,997 providers and
- 12 facilities received \$692,246,548 in Federal incentive payments
- 13 to implement electronic health records; and
- 14 WHEREAS, Health care providers in this Commonwealth report an
- 15 improved ability to recruit physicians coming out of medical
- 16 school when advanced information technology is employed at their
- 17 sites; and
- 18 WHEREAS, In 2012, Senate Bill No. 8 was signed into law,
- 19 enacting the Pennsylvania eHealth Information Technology Act and
- 20 establishing the Pennsylvania eHealth Partnership Authority and
- 21 a health information exchange; therefore be it
- 22 RESOLVED, That the House of Representatives designate
- 23 Wednesday, May 7, 2014, as "Pennsylvania Health Care Information
- 24 Technology Awareness Day"; and be it further
- 25 RESOLVED, That the House of Representatives recognize the
- 26 importance of raising awareness of health care information
- 27 technology and the vital role it will play in helping to save
- 28 lives and reduce the cost of health care for all Pennsylvanians;
- 29 and be it further
- 30 RESOLVED, That the House of Representatives welcome friends,

- 1 supporters and members of the Healthcare Information and
- 2 Management Systems Society (HIMSS) on their visit to the State
- 3 Capitol to promote better health care in this Commonwealth
- 4 through broader adoption of advanced health care information
- 5 technology and management systems on that day.
