INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, JUNE 9, 2014

A RESOLUTION

Supporting the struggle of the Ukrainian people in their fight 1 for religious and civil liberties. 2 3 WHEREAS, In 2010, rulings by the Constitutional Court of Ukraine restored powers to the President of Ukraine over the 4 5 military, the courts and enforcement agencies; and 6 WHEREAS, As a result of the Constitutional Court rulings, 7 prime ministers and regional governors could be appointed and 8 fired by the will of the Ukrainian president alone, with no 9 parliamentary oversight; and 10 WHEREAS, Ukrainian Media Holding and other media companies 11 lost their independence and ability to speak freely about the 12 country's ongoing political unrest after the Constitutional 13 Court rulings were implemented, and the majority of television 14 stations in Ukraine have been unable to voice independent 15 opinions; and

WHEREAS, Elections in Ukraine have been compromised, and ballot tampering made it impossible to determine the winner of five seats in the 2012 parliamentary election; and WHEREAS, Ballot tampering compromises the civil liberties guaranteed to the Ukrainian people in the Ukrainian Constitution; and

7 WHEREAS, Ukrainian President Yanucovych was removed from 8 office in February 2014 following ongoing political unrest; and 9 WHEREAS, Presidential elections, originally scheduled for 10 February 2015, will be held in Ukraine on May 25, 2014; and 11 WHEREAS, The interim prime minister of Ukraine promises that 12 the forthcoming new constitution will reestablish civil and 13 religious liberties; therefore be it

14 RESOLVED, That the House of Representatives support the 15 Ukrainian citizens in their efforts to restore civil and 16 religious liberties in their country; and be it further 17 RESOLVED, That copies of this resolution be transmitted to 18 the United States Department of State and to each member of 19 Congress from Pennsylvania.
