## AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, in general provisions, providing for
- character of discharge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 51 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 <u>§ 104. Character of discharge.</u>
- 9 (a) General rule. -- Whenever a particular character of
- 10 <u>discharge is a prerequisite to eligibility for receiving a</u>
- 11 benefit provided for in this title, an individual must have
- 12 received a discharge from service under conditions other than
- 13 dishonorable. Recipients of a discharge under conditions other
- 14 than dishonorable include the following:
- 15 <u>(1) A recipient of an honorable discharge.</u>
- 16 (2) A recipient of a general, under honorable
- 17 conditions, discharge.

- 1 (3) A recipient of a discharge under other than
- 2 <u>honorable conditions for which the recipient has been</u>
- determined to be eligible for benefits afforded by the United
- 4 <u>States Department of Veterans Affairs.</u>
- 5 (4) A RECIPIENT OF A DISCHARGE FOR WHICH BENEFITS ARE <--
- 6 PAYABLE UNDER 38 CFR 3.12 (RELATING TO CHARACTER OF
- 7 DISCHARGE).
- 8 (b) Exclusions. -- A recipient of a discharge under conditions <--
- 9 <u>other than dishonorable does not include a recipient of a</u>
- 10 dishonorable, bad conduct or undesirable discharge, or an
- 11 <u>uncharacterized discharge such as an entry-level separation.:</u> <--
- 12 (1) A DISHONORABLE, BAD CONDUCT OR UNDESIRABLE
- 13 <u>DISCHARGE</u>.
- 14 (2) A DISCHARGE OR RELEASE BECAUSE OF ONE OF THE
- OFFENSES SPECIFIED IN 38 CFR 3.12(D).
- 16 (C) UNCHARACTERIZED SEPARATIONS.--A RECIPIENT OF AN
- 17 UNCHARACTERIZED DISCHARGE OR SEPARATION SHALL BE EVALUATED BASED
- 18 UPON 38 CFR 3.12(K).
- 19 Section 2. This act shall take effect in 60 days.
