1 2 3 4 5 6 7 8 9 10 11 12 13 14 15 16 17 18 19	То	the act of July 28, 1966 (3rd Sp.Sess., P.L.87, No.3), entitled "An act providing for the establishment and operation of the University of Pittsburgh as an instrumentality of the Commonwealth to serve as a State- related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and the power and duties of such trustees; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing of accounts of expenditures from said appropriations; providing for public support and capital improvements; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the chancellor to make an annual report of the operations of the University of Pittsburgh," making appropriations for carrying the same into effect; and providing for a basis for payments of such appropriations, for a method of accounting for the funds appropriated and for certain fiscal information disclosure.

22		Section 1. The following sums, or as much thereof as may be
23	neo	cessary, are hereby appropriated to the Trustees of the
24	Un	versity of Pittsburgh for the fiscal year July 1, 2022, to
25	Ju	ne 30, 2023, for the purposes and in the amounts as shown:
26		(1) For general support \$159,082,000
27		(2) For rural education outreach \$3,513,000

Section 2. Payments to the University of Pittsburgh on
 account of the appropriations for all items as provided in
 section 1 shall be made on the basis of costs during the fiscal
 year.

5 Section 3. (a) Payments to the University of Pittsburgh of 6 the appropriations provided in section 1 shall be made monthly 7 during the fiscal year.

8 (b) Such monthly payments shall be made in accordance with 9 the provisions of section 2 on the basis of estimated costs. The 10 estimate of costs shall be submitted by the University of 11 Pittsburgh to the Secretary of Education, the General Assembly 12 and the State Treasurer not later than 30 days prior to the date 13 on which such payment is to be made.

Section 4. (a) The University of Pittsburgh shall apply the 14 15 moneys appropriated by this act only for such purposes as are 16 permitted in this act and shall at all times maintain proper records showing the application of such moneys. Not later than 17 18 120 days after the close of the fiscal year to which this act relates, the University of Pittsburgh shall file, with the 19 20 Secretary of Education, the General Assembly, the Auditor General of the Commonwealth and the chief administrator of each 21 branch campus, a statement setting forth the amounts and 22 23 purposes of all expenditures made from moneys appropriated by 24 this act and other university accounts during said fiscal year, as provided in section 2, used as a basis for receipt of any 25 26 appropriation during said fiscal year.

(b) Such statement of expenditures and costs shall be reviewed by the Auditor General of the Commonwealth, and he shall have the right, in respect to the moneys appropriated by this act, to audit and disallow expenditures made for purposes

not permitted by this act and to cause such sums to be recovered 1 2 and paid by the University of Pittsburgh to the State Treasurer. 3 In respect to expenditures made by the university from moneys other than those appropriated by this act, the Auditor General 4 shall have the right to review only, and he shall file annually 5 with the General Assembly such information concerning such 6 expenditures as the General Assembly or any of its committees 7 8 may require.

9 Section 5. The University of Pittsburgh shall provide full, 10 complete and accurate information as may be required by the 11 Department of Education or the chairperson or minority 12 chairperson of the Appropriations Committee of the Senate or the 13 chairperson or minority chairperson of the Appropriations 14 Committee of the House of Representatives.

15 Section 6. The University of Pittsburgh shall present and 16 report its financial statements required under the provisions of 17 this act in accordance with: the generally accepted accounting principles as prescribed by the National Association of College 18 and University Business Officers, the American Institute of 19 Certified Public Accountants, or their successors, or by any 20 21 other recognized authoritative body; the "Commonwealth of 22 Pennsylvania Budget Instructions for the State System of Higher 23 Education, State-Related Universities and Non-State-Related 24 Colleges and Universities"; and the financial reporting policies 25 and standards promulgated by the Commonwealth of Pennsylvania 26 and by the Federal Government that apply to the University of 27 Pittsburgh.

28 Section 7. No funds appropriated by this act may be used for 29 costs of personnel and operations of the environmental law 30 clinic.

1 Section 7.1. Funds appropriated by this act shall only be 2 used for costs directly related to the provision of instruction 3 for graduate and undergraduate students and costs incurred in 4 providing student-related services and community outreach 5 services, consistent with the existing laws of this 6 Commonwealth.

7 Section 8. This act shall take effect July 1, 2022, or8 immediately, whichever is later.
