AN ACT

Amending the act of June 28, 1935 (P.L.477, No.193), entitled 1 "An act providing for the payment of the salary, medical and 2 hospital expenses of certain employes of State and local 3 government who are injured or contract certain diseases in 5 the performance of their duty; and providing that absence during such injury shall not reduce any usual sick leave 6 period," further providing for disability benefits AND FOR DEFINITIONS. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 1 of the act of June 28, 1935 (P.L.477, No.193), referred to as the Enforcement Officer Disability 12 13 Benefits Law, is amended to read: 14 SECTION 1. - 15 (7), (8) [or], (12), (13), (14) or (15) or by the Delaware River
- 16 Port Authority if a member of the Delaware River Port Authority
- 17 Police or by the State owned university, State aided university, <--
- 18 community college or State related college or PARTICIPATING <-
- 19 university if a campus police officer or by the Allegheny County
- 20 Port Authority if a member of the Allegheny County Port
- 21 Authority Police or by the Allegheny County Housing Authority if
- 22 <u>a member of the Allegheny County Housing Authority Police</u> or by
- 23 the county, city, township or municipality, by which he is
- 24 employed, his full rate of salary, as fixed by ordinance or
- 25 resolution, until the disability arising therefrom has ceased.
- 26 All medical and hospital bills, incurred in connection with any
- 27 such injury, shall be paid by the Commonwealth of Pennsylvania
- 28 or by the Delaware River Port Authority or by the State owned <--
- 29 <u>university</u>, <u>State-aided university</u>, <u>community college or State-</u>
- 30 related college or PARTICIPATING university or by the Allegheny <--

- 1 County Port Authority or by the Allegheny County Housing
- 2 Authority or by such county, township or municipality. During
- 3 the time salary for temporary incapacity shall be paid by the
- 4 Commonwealth of Pennsylvania or by the Delaware River Port
- 5 Authority or by the State-owned university, State-aided <--
- 6 university, community college or State related college or
- 7 PARTICIPATING university or by the Allegheny County Port <--
- 8 <u>Authority or by the Allegheny County Housing Authority</u> or by the
- 9 county, city, borough, town or township, any workmen's
- 10 compensation, received or collected by any such employe for such
- 11 period, shall be turned over to the Commonwealth of Pennsylvania
- 12 or to the Delaware River Port Authority or by the State owned <-
- 13 <u>university</u>, <u>State-aided university</u>, <u>community college or State-</u>
- 14 <u>related college or PARTICIPATING university or the Allegheny</u> <--
- 15 County Port Authority or the Allegheny County Housing Authority
- 16 or to such county, city, borough, town or township, and paid
- 17 into the treasury thereof, and if such payment shall not be so
- 18 made by the employe the amount so due the Commonwealth of
- 19 Pennsylvania, the Delaware River Port Authority or by the State <--

- 20 owned university, State aided university, community college or
- 21 State related college or PARTICIPATING university or the
- 22 Allegheny County Port Authority or the Allegheny County Housing
- 23 <u>Authority</u> or the county, city, borough, town or township shall
- 24 be deducted from any salary then or thereafter becoming due and
- 25 owing.
- 26 (b) In the case of:
- 27 (1) the State Police Force;
- 28 (2) enforcement officers and investigators employed by the
- 29 Pennsylvania Liquor Control Board;
- 30 (3) the parole agents, enforcement officers and

- 9 CUSTODY AND CONTROL OF INMATES;
- 10 who have served for four consecutive years or longer, diseases
- 11 of the heart and tuberculosis of the respiratory system,
- 12 contracted or incurred by any of them after four years of
- 13 continuous service as such, and caused by extreme overexertion
- 14 in times of stress or danger or by exposure to heat, smoke,
- 15 fumes or gases, arising directly out of the employment shall be
- 16 compensable in accordance with the terms hereof; and unless any
- 17 such disability shall be compensable under the compensation laws
- 18 as having been caused by accidental injury, such disability
- 19 shall be compensable as occupational disease disabilities are
- 20 presently compensable under the compensation laws of this
- 21 Commonwealth. It shall be presumed that tuberculosis of the
- 22 respiratory system contracted or incurred after four consecutive
- 23 years of service was contracted or incurred as a direct result
- 24 of employment.
- 25 (c) In the case of any person receiving benefits pursuant to
- 26 this act, the statutes of limitations set forth in sections
- 27 306.1, 315, 413, and 434 of the act of June 2, 1915 (P.L.736,
- 28 No.338), known as the "Workers' Compensation Act," shall not
- 29 begin to run until the expiration of the receipt of benefits
- 30 pursuant to this act.

- 1 (d) (1) All payments herein required to be made by the
- 2 Commonwealth of Pennsylvania on account of any member of the
- 3 State Police Force shall be made from moneys appropriated to the
- 4 Pennsylvania State Police.
- 5 (2) Any payments required to be made on account of any
- 6 enforcement officer or investigator employed by the Pennsylvania
- 7 Liquor Control Board shall be made from appropriations out of
- 8 the State Stores Fund.
- 9 (3) Any payments required to be made on account of any
- 10 parole agent, enforcement officer or investigator employed by
- 11 the Pennsylvania Board of Probation and Parole shall be made
- 12 from moneys appropriated to the Pennsylvania Board of Probation
- 13 and Parole.
- 14 (4) Any payments required to be made on account of Capitol
- 15 Police officers shall be made from moneys appropriated to the
- 16 Department of General Services.
- 17 (5) Any payments required to be made on account of any
- 18 correction employe shall be made from moneys appropriated to the
- 19 Department of Corrections.
- 20 (6) Any payments required to be made on account of any
- 21 psychiatric security aides shall be made from moneys
- 22 appropriated to the Department of Human Services or the
- 23 Department of Corrections where appropriate.
- 24 (6.1) Any payments required to be made on account of any
- 25 campus police officers employed by a State-owned university,
- 26 State aided university, community college or State related
- 27 <u>college or PARTICIPATING university shall be made from moneys</u> <--

- 28 appropriated to the State-owned university, State-aided
- 29 <u>university</u>, <u>community college or State-related college or</u>
- 30 PARTICIPATING university.

- 1 (6.2) Any payments required to be made on account of any
- 2 Rangers, Ranger Supervisors, Ranger Operations Specialists and
- 3 Ranger Trainees DCNR RANGERS, DCNR RANGER SUPERVISORS, DCNR
- 4 RANGER OPERATIONS SPECIALISTS AND DCNR RANGER TRAINEES employed
- 5 by the Department of Conservation and Natural Resources shall be
- 6 made from moneys appropriated to the Department of Conservation
- 7 and Natural Resources.
- 8 (6.3) Any payments required to be made on account of any
- 9 members of the Fort Indiantown Gap Police Force employed by the
- 10 Department of Military and Veterans Affairs shall be made from
- 11 moneys appropriated to the Department of Military and Veterans
- 12 Affairs.
- 13 (6.4) Any payments required to be made on account of any
- 14 <u>special investigators</u> INVESTIGATIVE STAFF of the Office of
- 15 <u>Inspector General shall be made from moneys appropriated to the</u>
- 16 Office of Inspector General.
- 17 (6.5) Any payments required to be made on account of any
- 18 members of the Allegheny County Port Authority Police shall be
- 19 made from any moneys appropriated to the Allegheny County Port
- 20 Authority.
- 21 (6.6) Any payments required to be made on account of any
- 22 members of the Allegheny County Housing Authority Police shall
- 23 be made from any moneys appropriated to the Allegheny County
- 24 Housing Authority.
- 25 (7) Any payments required to be made on account of any drug
- 26 enforcement agent or special agents shall be made from moneys
- 27 appropriated to the Office of Attorney General and any payments
- 28 required to be made on account of any fireman employed by the
- 29 Commonwealth shall be made from moneys appropriated to the
- 30 employing agency.

- 1 (8) Any payments required to be made on account of any
- 2 enforcement officers or investigators of the Pennsylvania Game
- 3 Commission shall be made from moneys appropriated to the
- 4 Pennsylvania Game Commission or executively authorized from the
- 5 Game Fund under 34 Pa.C.S. Ch. 5 Subch. B (relating to Game
- 6 Fund).
- 7 (9) Any payments required to be made on account of any
- 8 enforcement officers or investigators of the Pennsylvania Fish
- 9 and Boat Commission shall be made from moneys appropriated to
- 10 the Pennsylvania Fish and Boat Commission or executively
- 11 authorized from the Fish Fund under 30 Pa.C.S. Ch. 5 Subch. B
- 12 (relating to the Fish Fund) or the Boat Fund under 30 Pa.C.S.
- 13 Ch. 5 Subch. C (relating to the Boat Fund).
- 14 SECTION 2.1. FOR THE PURPOSES OF THIS ACT, THE [TERM
- 15 "FIREMAN" SHALL MEAN AND INCLUDE THE FOLLOWING: FOLLOWING WORDS

- 16 AND PHRASES SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS
- 17 <u>SECTION UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE:</u>
- 18 <u>"FIREMAN." ANY OF THE FOLLOWING:</u>
- 19 (1) PAID FIREMEN NOT EMPLOYED BY THE COMMONWEALTH.
- 20 (2) EMERGENCY MEDICAL SERVICES PERSONNEL EMPLOYED WITHIN A
- 21 CITY FIRE DEPARTMENT.
- 22 (3) FIREMEN OF AIRPORT AUTHORITIES, INCLUDING FIRE
- 23 SUPPRESSION INSTRUCTORS.
- 24 (4) FIRE AND SAFETY MARSHALS WHO ARE FIREMEN EMPLOYED BY THE
- 25 COMMONWEALTH.
- 26 (5) FIRE ACADEMY INSTRUCTORS EMPLOYED AT THE STATE FIRE
- 27 ACADEMY.
- 28 (6) ASSISTANT FIRE MARSHALS EMPLOYED BY THE COMMONWEALTH.
- 29 (7) FOREST PATROLMEN AND FOREST TECHNICIANS EMPLOYED BY THE
- 30 COMMONWEALTH.

- 1 "PARTICIPATING UNIVERSITY." ANY OF THE FOLLOWING THAT ELECTS
- 2 TO PARTICIPATE IN THIS ACT BY SUBMITTING A NOTICE TO THE
- 3 DEPARTMENT OF LABOR AND INDUSTRY, WHICH ELECTION SHALL BE
- 4 IRREVOCABLE AFTER PARTICIPATION IN THIS ACT COMMENCES:
- 5 <u>(1) A STATE-OWNED UNIVERSITY.</u>
- 6 (2) A COMMUNITY COLLEGE.
- 7 (3) A STATE-RELATED COLLEGE OR UNIVERSITY.
- 8 Section 2. This act shall take effect in 60 days.
