AN ACT

- 1 Amending Title 35 (Health and Safety) of the Pennsylvania
- 2 Consolidated Statutes, in Commonwealth services, providing
- 3 for online training for firefighters.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 35 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 7388. Online training for firefighters.
- 9 (a) General rule. -- Under section 2413 of the act of March 4,
- 10 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, the
- 11 Office of the State Fire Commissioner shall establish guidelines
- 12 for the use of money deposited into the Online Training Educator
- 13 and Training Reimbursement Account and dedicated for the
- 14 purposes of developing, delivering and sustaining training
- 15 programs for firefighters. The guidelines shall provide that the
- 16 money be used for online training for volunteer and career
- 17 firefighters and shall include, at a minimum, the following:

- 1 (1) Participation in the training shall be on a
- 2 voluntary basis.
- 3 (2) The training shall be offered free of charge.
- 4 (3) The training shall be incorporated into the Train PA
- 5 <u>system.</u>
- 6 (b) Prioritization. -- In establishing online training
- 7 courses, the commissioner shall prioritize specific topics.
- 8 (c) Certificate of completion. -- The commissioner shall
- 9 provide a certificate of completion to an individual who
- 10 successfully completes an online training program.
- 11 (d) Publication. -- The Office of the State Fire Commissioner
- 12 <u>shall post a complete listing of the available online training</u>
- 13 courses on the office's publicly accessible Internet website.
- 14 (e) Limitation. The commissioner may not use more than 5% <--
- 15 of the money in the Online Training Educator and Training
- 16 Reimbursement Account for administrative costs.
- 17 Section 2. This act shall take effect in 60 days.
