- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the

- providing for declaration of judicial emergencies.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 42 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 5506. Declaration of judicial emergencies.
- 9 (a) Judicial emergencies. -- Notwithstanding any other
- 10 provision of this chapter, if the time within which an action
- 11 <u>must be commenced under this chapter is set to expire during IN_</u> <--
- 12 THE EVENT OF a judicial emergency declared by a governing
- 13 <u>authority under Article V of the Constitution of Pennsylvania, a</u>
- 14 law of this Commonwealth, a rule of court or other judicial
- 15 order BY THE SUPREME COURT OR ANY AGENCY OR UNIT OF THE UNIFIED <--
- 16 JUDICIAL SYSTEM EXERCISING A POWER OR PERFORMING A DUTY IN
- 17 ACCORDANCE WITH SECTION 1721 (RELATING TO DELEGATION OF POWERS),
- 18 IF THE TIME WITHIN WHICH AN ACTION MUST BE COMMENCED UNDER THIS

11	(1) This section shall apply to any judicial district
12	for which a judicial emergency is declared. If a Statewide

14	section shall apply to all judicial districts.
15	(2) This section shall be retroactive to March 18, 2020.
16	ANY OF THE FOLLOWING, WHICHEVER OCCURS FIRST:
17	(I) THE EXPIRATION OF THE DECLARED JUDICIAL
18	EMERGENCY.
19	(II) THE JUDICIAL DISTRICT ESTABLISHES A METHOD BY
20	WHICH THE ACTION MAY BE COMMENCED BY RULE OF COURT OR
21	OTHER JUDICIAL ORDER DURING THE JUDICIAL EMERGENCY.
22	(III) THE EFFECTIVE DATE OF THE JUDICIAL EMERGENCY
23	IF THE JUDICIAL DISTRICT HAS ESTABLISHED A METHOD BY
24	WHICH THE ACTION MAY BE COMMENCED BY RULE OF COURT OR
25	OTHER JUDICIAL ORDER PRIOR TO SUCH EFFECTIVE DATE.
26	(3) AN ACTION COMMENCED DURING THE ADDITIONAL 30-DAY
27	PERIODS SPECIFIED UNDER PARAGRAPH (2)(I), (II) OR (III) SHALL
28	BE DEEMED TIMELY FILED UNDER SECTION 5503(A) (RELATING TO
29	COMMENCEMENT OF MATTERS).
30	(B) APPLICABILITY THIS SECTION SHALL APPLY TO ANY JUDICIAL

- 1 DISTRICT FOR WHICH A JUDICIAL EMERGENCY IS DECLARED. IF A
- 2 STATEWIDE JUDICIAL EMERGENCY IS DECLARED BY A GOVERNING
- 3 AUTHORITY, THIS SECTION SHALL APPLY TO ALL JUDICIAL DISTRICTS.
- 4 (C) CONSTRUCTION. -- NOTHING IN THIS SECTION SHALL BE
- 5 CONSTRUED TO REDUCE THE TIME WITHIN WHICH AN ACTION MUST BE
- 6 COMMENCED AS ESTABLISHED BY ANY OTHER LAW OF THIS COMMONWEALTH,
- 7 RULE OF COURT OR OTHER JUDICIAL ORDER.
- 8 Section 2. This act shall take effect immediately.
