15	(b.1) (1) A student with a disability as defined in 22 Pa.
16	<u>Code § 14.101 who has reached twenty-one (21) years of age</u>
17	during the 2021-2022 school year or between the end of the 2021-
18	2022 school year and the beginning of the 2022-2023 school year
19	and is enrolled for the 2021-2022 school year is entitled to
20	attend a school entity for the 2022-2023 school year and the

1	school entity shall enroll the student if a parent or guardian
2	and the student elects to enroll no later than July 15, 2022.
3	<u>(2) A student with a disability as defined in 22 Pa. Code §</u>
4	14.101 who has reached eighteen (18), nineteen (19) or twenty
5	(20) years of age during the 2021-2022 school year or between
6	the end of the 2021-2022 school year and the beginning of the
7	2022-2023 school year and is enrolled for the 2021-2022 school
8	year is entitled to attend a school entity for an additional
9	school year upon reaching twenty-one (21) years of age and the
10	school entity shall enroll the student if a parent or guardian
11	and the student elects to enroll no later than July 15, 2022.
12	(3) The Department of Education shall develop a standard
13	election form for a parent or guardian to elect to enroll the
14	student and the form shall be made available on the department's
15	publicly accessible Internet website.

17	(c.1) Notwithstanding any other provision of law to the
18	contrary, the following shall apply to a student enrolled in a
19	school entity under subsection (b.1):
20	(1) The school entity shall implement the student's most
21	recent IEP.
22	(2) The student's attendance shall be included in the school
23	entity's average daily membership.
24	(3) The school entity shall provide extended school year
25	services during the summer after the 2021-2022 school year in
26	accordance with the student's most recent IEP.
27	(4) The school entity shall take all steps necessary to
28	comply with the Individuals with Disabilities Education Act
29	(Public Law 91-230, 20 U.S.C. § 1400 et seq.) and 22 Pa. Code
30	Ch. 14 (relating to special education services and programs).
