AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled 1 "An act relating to the finances of the State government; 2 providing for cancer control, prevention and research, for 3 ambulatory surgical center data collection, for the Joint 4 Underwriting Association, for entertainment business 5 financial management firms, for private dam financial 6 assurance and for reinstatement of item vetoes; providing for 7 the settlement, assessment, collection, and lien of taxes, 8 9 bonus, and all other accounts due the Commonwealth, the collection and recovery of fees and other money or property 10 due or belonging to the Commonwealth, or any agency thereof, 11 including escheated property and the proceeds of its sale, 12 the custody and disbursement or other disposition of funds 13 and securities belonging to or in the possession of the 14 Commonwealth, and the settlement of claims against the 15 Commonwealth, the resettlement of accounts and appeals to the 16 courts, refunds of moneys erroneously paid to the 17 Commonwealth, auditing the accounts of the Commonwealth and 18 19 all agencies thereof, of all public officers collecting moneys payable to the Commonwealth, or any agency thereof, 20 and all receipts of appropriations from the Commonwealth, 21 22 authorizing the Commonwealth to issue tax anticipation notes 23 to defray current expenses, implementing the provisions of section 7(a) of Article VIII of the Constitution of 24 Pennsylvania authorizing and restricting the incurring of 25 certain debt and imposing penalties; affecting every 26 department, board, commission, and officer of the State 27 government, every political subdivision of the State, and 28 29 certain officers of such subdivisions, every person, 30 association, and corporation required to pay, assess, or collect taxes, or to make returns or reports under the laws 31 imposing taxes for State purposes, or to pay license fees or 32 other moneys to the Commonwealth, or any agency thereof, 33

1 2 3 4	every State depository and every debtor or creditor of the Commonwealth," in emergency COVID-19 response, providing for appropriations from the account and for Nonprofit Economic Emergency Delivery System Grants Program.
5	The General Assembly of the Commonwealth of Pennsylvania

3	(a) Use of fundsFrom money appropriated to the department
4	<u>for COVID Relief - Nonprofit Economic Emergency Delivery System</u>
5	Grants Program, \$200,000,000 shall be transferred to the
6	authority and shall be used to make grants under this section.
7	(b) Establishment of programThe authority shall establish
8	the program as a Statewide competitive grant program.
9	(c) Purpose of programThe program shall receive
10	applications and award grants to eligible community-based
11	nonprofit organizations in accordance with this section.
12	(d) ApplicationThe authority shall develop an application
13	for eligible community-based nonprofit organizations to apply
14	for grants under this section within 30 days of the effective
15	date of this section. The application shall be made available
16	and posted on the authority's publicly accessible Internet
17	website and shall be in a form that can be completed
18	electronically or through the United States mail.
19	(e) DeadlineNo application for a grant under this section
20	may be submitted after September 30, 2020.
21	(f) GuidelinesThe authority shall establish guidelines
22	that are consistent with the provisions of this section within
23	30 days of the effective date of this section. The guidelines
24	shall be:
25	(1) Submitted to the Legislative Reference Bureau for
26	publication as a notice in the Pennsylvania Bulletin.
27	(2) Posted on the authority's publicly accessible

4	(ii) Community-based, federally qualified health
5	centers and rural health clinics.
6	(iii) Substance abuse treatment facilities.
7	(iv) Domestic violence centers.
8	(v) Organizations operating transportation and food
9	distribution systems.
10	(vi) Employment and workforce training and
11	educational centers.
12	(vii) Alternative learning and career training
13	institutions.
14	(viii) Organizations serving intellectual or
15	developmental disabilities.
16	(ix) Early intervention service providers.
17	(x) Mental health and substance abuse counseling.

12	(3) An eligible community-based nonprofit organization	
13	that has already received public funding during the COVID-19	
14	pandemic must explain in its application why additional	
15	funding is necessary above and beyond the public funding	
16	already received.	
17	(h) Grant limitsThe authority may award a grant to an	
18	eligible community-based nonprofit organization not to exceed	
19	<u>\$500,000.</u>	
20	(i) Award of grantsThe authority shall award grants and	
21	make grant payments under this section no later than November	
22	<u>30, 2020.</u>	
23	(j) ExpirationThis section shall expire after the money	
24	transferred to the authority under subsection (a) has been	
25	exhausted or December 1, 2020, whichever occurs first.	
26	(k) DefinitionsAs used in this section, the following	
27	words and phrases shall have the meanings given to them in this	
28	subsection unless the context clearly indicates otherwise:	
29	"Authority. " The Commonwealth Financing Authority.

1	exempt 501(c)(3) institution that meets the criteria for grants
2	under subsection (g) and that was subject to financial strain
3	due to closure, increased service delivery or a loss of revenue
4	as a result of the COVID-19 pandemic and the proclamation of
5	disaster emergency issued by the Governor on March 6, 2020,
6	published at 50 Pa.B. 1644 (March 21, 2020), and any renewal of
7	the state of disaster emergency.
8	"Program." The Nonprofit Economic Emergency Delivery System
9	(NEEDS) Grants Program established under this section.
10	Section 3. This act shall take effect immediately.
