AN ACT

1 Amending Title 74 (Transportation) of the Pennsylvania
2 Consolidated Statutes, in sustainable mobility options,
3 further providing for fund and for operating program.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 1506(c)(1) of Title 74 of the
7 Pennsylvania Consolidated Statutes is amended to read:

8 § 1506. Fund.

9 * * *

10 (c) Other deposits.--The following shall be deposited into
11 the fund annually:

12 (1) [4.4%] 6.15% of the amount collected under Article
13 II of the Tax Reform Code. Revenues under this paragraph
14 shall be deposited into the fund by the 20th day of each
15 month for the preceding month. The amount deposited under
16 this paragraph is estimated to be equivalent to the money
17 available to the department from the following sources:

18 (i) The Supplemental Public Transportation Account

1 established under former section 1310.1 (relating to
2 supplemental public transportation assistance funding).

3 (ii) The amount appropriated annually by the
4 Commonwealth from the General Fund for mass transit
5 programs pursuant to a General Appropriations Act.

7 Section 2. Section 1513(c)(3) and (d)(2) of Title 74 are
8 amended and subsection (d) is amended by adding a paragraph to
9 read:

10 § 1513. Operating program.

12 (c) Distribution formula.--

13 * * *

14 (3) (i) For the 2007-2008 fiscal year, no local
15 transportation organization shall receive total financial
16 assistance under this subsection that would be more than
17 50% higher than the amount it receives under paragraph
18 (2)(i). [For each subsequent fiscal year]

19 (ii) For fiscal years 2008-2009 through 2023-2024,
20 the increase in the total financial assistance provided
21 to each local transportation organization shall not
22 exceed 20% of the prior year allocation.

23 (iii) For the 2024-2025 fiscal year and each
24 subsequent fiscal year, the increase in the total
25 financial assistance provided to each local
26 transportation organization may exceed 20% of the prior
27 year allocation.

29 (d) Local match requirements.--

30 * * *

1 (2) [Beginning] Except as provided under paragraph
2 (2.1), beginning in fiscal year 2007-2008 and each fiscal
3 year thereafter, if the local matching funds provided are
4 less than 15% of the amount of financial assistance received,
5 the local transportation organization's required local
6 matching funds shall increase annually in order to meet the
7 15% requirement set forth under paragraph (1)(i). The local
8 matching funds shall be increased annually by a minimum of 5%
9 above the amount of local matching funds provided in the
10 previous fiscal year unless a lesser amount is necessary to
11 meet the 15% requirement set forth under paragraph (1)(i).

12 (2.1) For fiscal years 2024-2025 through 2028-2029, the
13 secretary may adjust and hold harmless the amount of annual
14 increase in local matching funds required under paragraph
15 (2).

17 Section 3. This act shall take effect in 60 days.
