AN ACT

1	Amending the act of April 9, 1929 (P.L.177, No.175), entitled
2	"An act providing for and reorganizing the conduct of the
3	executive and administrative work of the Commonwealth by the
4	Executive Department thereof and the administrative
5	departments, boards, commissions, and officers thereof,
6	including the boards of trustees of State Normal Schools, or
7	Teachers Colleges; abolishing, creating, reorganizing or
8	authorizing the reorganization of certain administrative
9	departments, boards, and commissions; defining the powers and
10	duties of the Governor and other executive and administrative
11	officers, and of the several administrative departments,
12	boards, commissions, and officers; fixing the salaries of the
13	Governor, Lieutenant Governor, and certain other executive
14	and administrative officers; providing for the appointment of
15	certain administrative officers, and of all deputies and
16	other assistants and employes in certain departments, boards,
17	and commissions; providing for judicial administration; and
18	prescribing the manner in which the number and compensation
19	of the deputies and all other assistants and employes of
20	certain departments, boards and commissions shall be
21	determined," providing for indoor and outdoor recreation
22	during COVID-19 disaster emergency.
23	The General Assembly of the Commonwealth of Pennsylvania
24	hereby enacts as follows:
25	Section 1. The act of April 9, 1929 (P.L.177, No.175), known
26	as The Administrative Code of 1929, is amended by adding an
27	article to read:

2	INDOOR AND OUTDOOR RECREATION DURING
3	COVID-19 DISASTER EMERGENCY
4	<u>Section 2101-E. Definitions.</u>
5	The following words and phrases when used in this article
6	shall have the meanings given to them in this section unless the
7	context clearly indicates otherwise:
8	"COVID-19 disaster emergency." The proclamation of disaster
9	emergency issued by the Governor on March 6, 2020, published at
10	50 Pa.B. 1644 (March 21, 2020), and any renewal of the state of
11	<u>disaster emergency.</u>
12	"Event facility." A venue hosting recreational and amateur
13	sports organizations, teams and individuals not affiliated with
14	a public or nonpublic school for games, competitions, intramural
15	play, scrimmages, practices, conditioning, drills and other
16	training activities.
17	Section 2102-E. Operation of event facilities.
18	Beginning on the effective date of this section, an event
19	facility may operate according to the requirements under section
20	<u>2103-E.</u>
21	<u>Section 2103-E. Requirements.</u>
22	An event facility shall be permitted to operate:
23	(1) At a minimum of 50% occupancy capacity indoors and
24	outdoors with social distancing consistent with the
25	guidelines issued by the Centers for Disease Control and
26	Prevention.
27	(2) With more than a 50% occupancy capacity indoors and
28	outdoors if social distancing guidelines issued by the
29	Centers for Disease Control and Prevention can be maintained.
30	Section 2104-E. Occupancy limitations imposed by executive

2	Notwithstanding any other provision of law, an event facility
3	shall not be subject to an executive order during the COVID-19
4	disaster emergency which limits the occupancy of an event
5	facility to less than 50% occupancy capacity.
6	Section 2105-E. Publication of notice.
7	(a) General ruleWithin 10 days of the termination or
8	expiration of the declaration of disaster emergency issued by
9	the Governor on March 6, 2020, published at 50 Pa.B. 1644 (March
10	21, 2020), the Secretary of the Commonwealth shall transmit a
11	notice to the Legislative Reference Bureau for publication in
12	<u>the Pennsylvania Bulletin.</u>
13	(b) NonapplicabilitySubsection (a) shall not apply if the
14	Governor, or an officer acting on behalf of the Governor,
15	transmits a similar notice to the Legislative Reference Bureau
16	as required under another act.
17	Section 2106-E. Expiration.
18	This article shall expire upon publication of the notice
19	<u>under section 2105-E.</u>

20 Section 2. This act shall take effect immediately.
