A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, in taxation and finance, providing for
- 3 spending limitations.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- 8 That Article VIII be amended by adding a section to read:
- 9 § 18. Spending limitations.
- 10 (a) Except as provided in subsection (c), total spending by
- 11 the Commonwealth in a fiscal year shall not exceed the spending
- 12 appropriation limit as provided in this section.
- 13 (b) The spending appropriation limit for any fiscal year
- 14 shall be equal to total appropriations made during the
- 15 immediately prior fiscal year, adjusted by the lesser of:
- 16 (1) the average percentage change in personal income in this
- 17 Commonwealth for the three preceding calendar years as reported

- 1 by the Federal Government or as determined pursuant to an act of
- 2 the General Assembly; or
- 3 (2) the average percentage change in inflation for the three
- 4 preceding calendar years plus the average percentage change in
- 5 the State population for the three preceding years as reported
- 6 by the annual Federal decennial census estimates and adjusted
- 7 every decade to match the official Federal decennial census.
- 8 (c) The spending appropriation limit may be exceeded in any
- 9 fiscal year:
- 10 (1) to respond to a declared emergency, if the General
- 11 Assembly approves by the affirmative vote of two-thirds of the
- 12 members elected to each House of the General Assembly; or
- 13 (2) in other situations if the Governor requests at least 30
- 14 days prior to the beginning of the fiscal year and the General
- 15 Assembly approves by the affirmative vote of two-thirds of the
- 16 members elected to each House of the General Assembly.
- 17 (d) For purposes of this section:
- 18 (1) "Inflation" shall mean the percentage change in the
- 19 <u>United States Department of Labor, Bureau of Labor Statistics,</u>
- 20 Consumer Price Index for All Urban Consumers, not seasonally
- 21 adjusted; all items index, or its successor index.
- 22 (2) "Total spending by the Commonwealth" shall mean the
- 23 total of the amounts approved as executive authorizations by the
- 24 Governor plus the total amounts of appropriations made by the
- 25 General Assembly, excluding appropriations made with money
- 26 received from the Federal Government.
- 27 Section 2. (a) Upon the first passage by the General
- 28 Assembly of this proposed constitutional amendment, the
- 29 Secretary of the Commonwealth shall proceed immediately to
- 30 comply with the advertising requirements of section 1 of Article

- 1 XI of the Constitution of Pennsylvania and shall transmit the
- 2 required advertisements to two newspapers in every county in
- 3 which such newspapers are published in sufficient time after
- 4 passage of this proposed constitutional amendment.
- 5 (b) Upon the second passage by the General Assembly of this
- 6 proposed constitutional amendment, the Secretary of the
- 7 Commonwealth shall proceed immediately to comply with the
- 8 advertising requirements of section 1 of Article XI of the
- 9 Constitution of Pennsylvania and shall transmit the required
- 10 advertisements to two newspapers in every county in which such
- 11 newspapers are published in sufficient time after passage of
- 12 this proposed constitutional amendment. The Secretary of the
- 13 Commonwealth shall submit this proposed constitutional amendment
- 14 as a single ballot question to the qualified electors of this
- 15 Commonwealth at the first primary, general or municipal election
- 16 which meets the requirements of and is in conformance with
- 17 section 1 of Article XI of the Constitution of Pennsylvania and
- 18 which occurs at least three months after the proposed
- 19 constitutional amendment is passed by the General Assembly.
