## AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An act relating to alcoholic liquors, alcohol and malt and 2 brewed beverages; amending, revising, consolidating and 3 changing the laws relating thereto; regulating and restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 7 8 persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 licenses and regulations and liquor, alcohol and malt and brewed beverages, further providing for authority to issue 17 18 liquor licenses to hotels, restaurants and clubs, for sales 19 by liquor licensees and restrictions, for sale of malt or 20 brewed beverages by liquor licensees, for retail dispensers' 21 restrictions on purchases and sales, for unlawful acts 22 relative to malt or brewed beverages and licensees and for 23 premises to be vacated by patrons. 24

- 25 The General Assembly of the Commonwealth of Pennsylvania
- 26 hereby enacts as follows:
- 27 Section 1. Sections 401(a) and 406(a)(4) of the act of April
- 12, 1951 (P.L.90, No.21), known as the Liquor Code, are amended 28
- 29 to read:

- 1 Section 401. Authority to Issue Liquor Licenses to Hotels,
- 2 Restaurants and Clubs. -- (a) Subject to the provisions of this
- 3 act and regulations promulgated under this act, the board shall
- 4 have authority to issue a retail liquor license for any premises
- 5 kept or operated by a hotel, restaurant or club and specified in
- 6 the license entitling the hotel, restaurant or club to purchase
- 7 liquor from a Pennsylvania Liquor Store and to keep on the
- 8 premises such liquor and, subject to the provisions of this act
- 9 and the regulations made thereunder, to sell the same and also
- 10 malt or brewed beverages to guests, patrons or members for
- 11 consumption on the hotel, restaurant or club premises. Such
- 12 licensees[, other than clubs <u>subject to the restriction in</u>
- 13 <u>section 406(a)(4)(ii)</u>,] shall be permitted to sell malt or
- 14 brewed beverages for consumption off the premises where sold in

- 15 quantities of not more than one hundred ninety-two fluid ounces
- 16 in a single sale to one person as provided for in section 407.
- 17 Such licenses shall be known as hotel liquor licenses,
- 18 restaurant liquor licenses and club liquor licenses,
- 19 respectively. No person who holds any public office that
- 20 involves the duty to enforce any of the penal laws of the United
- 21 States, this Commonwealth or of any political subdivision of
- 22 this Commonwealth may have any interest in a hotel or restaurant
- 23 liquor license. This prohibition applies to anyone with arrest
- 24 authority, including, but not limited to, United States
- 25 attorneys, State attorneys general, district attorneys, sheriffs
- 26 and police officers. This prohibition shall also apply to
- 27 magisterial district judges, judges or any other individuals who
- 28 can impose a criminal sentence. This prohibition does not apply
- 29 to members of the General Assembly, township supervisors, city
- 30 councilpersons, mayors without arrest authority and any other

- 1 public official who does not have the ability to arrest or the
- 2 ability to impose a criminal sentence. This section does not
- 3 apply if the proposed premises are located outside the
- 4 jurisdiction of the individual in question.

- 6 Section 406. Sales by Liquor Licensees; Restrictions.--(a)
- 7 \* \* \*
- 8 (4) (i) Hotel and restaurant liquor licensees, municipal
- 9 golf course restaurant liquor licensees and privately-owned
- 10 public golf course restaurant licensees which do not qualify for
- 11 and purchase such special permit, their servants, agents or
- 12 employes may sell liquor and malt or brewed beverages only after
- 13 seven o'clock antemeridian of any day and until two o'clock
- 14 antemeridian of the following day, and shall not sell after two
- 15 o'clock antemeridian on Sunday. No club licensee or its
- 16 servants, agents or employes may sell liquor or malt or brewed
- 17 beverages between the hours of three o'clock antemeridian and
- 18 seven o'clock antemeridian on any day. No public service liquor
- 19 licensee or its servants, agents, or employes may sell liquor or
- 20 malt or brewed beverages between the hours of two o'clock
- 21 antemeridian and seven o'clock antemeridian on any day.
- 22 <u>(ii) No club licensee or its servants, agents or employes</u>
- 23 <u>may sell <del>liquor or</del> malt or brewed beverages for off-premises</u>
- 24 consumption between the hours of two o'clock antemeridian and
- 25 seven o'clock antemeridian on any day. <del>during the time period</del>

- 30 Section 2. Sections 407(a)(1) and 442(a)(1)(i) of the act,

- 1 amended June 5, 2020 (P.L.213, No.29), are amended to read:
- 2 Section 407. Sale of Malt or Brewed Beverages by Liquor
- 3 Licensees.--(a) (1) Every liquor license issued to a hotel,
- 4 restaurant, club, or a railroad, pullman or steamship company
- 5 under this subdivision (A) for the sale of liquor shall
- 6 authorize the licensee to sell malt or brewed beverages at the
- 7 same places but subject to the same restrictions and penalties
- 8 as apply to sales of liquor, except that licensees [other than

- 9 clubs] subject to the restriction in section 406(a)(4)(ii) may
- 10 sell malt or brewed beverages for consumption off the premises
- 11 where sold in quantities of not more than one hundred ninety-two
- 12 fluid ounces in a single sale to one person. The sales may be
- 13 made in either open or closed containers, Provided, however,
- 14 That a municipality may adopt an ordinance restricting open
- 15 containers in public places. No licensee under this subdivision
- 16 (A) shall at the same time be the holder of any other class of
- 17 license, except a retail dispenser's license authorizing the
- 18 sale of malt or brewed beverages only. Sales of malt or brewed
- 19 beverages must occur on the licensed premises.

- 21 Section 442. Retail Dispensers' Restrictions on Purchases
- 22 and Sales. -- (a) (1) (i) No retail dispenser shall purchase or
- 23 receive any malt or brewed beverages except in original
- 24 containers as prepared for the market by the manufacturer at the
- 25 place of manufacture. The retail dispenser may thereafter break
- 26 the bulk upon the licensed premises and sell or dispense the
- 27 same for consumption on or off the premises so licensed. No
- 28 retail dispenser may sell malt or brewed beverages for
- 29 consumption off the premises in quantities in excess of one
- 30 hundred ninety-two fluid ounces. Sales may be made in open or

- 1 closed containers, Provided, however, That a municipality may
- 2 adopt an ordinance restricting open containers in public places.
- 3 No club licensee may sell any malt or brewed beverages for
- 4 consumption off the premises [where sold, except during the time\_<--
- 5 period covered by the proclamation of disaster emergency issued
- 6 by the Governor on March 6, 2020, published at 50 Pa.B. 1644
- 7 (March 21, 2020), and any renewal of the state of disaster
- 8 <u>emergency</u> or] to persons not members of the club. Sales of malt <--
- 9 or brewed beverages must occur on the licensed premises.

- 21 seven o'clock antemeridian on any day.

- 26 premises consumption between the hours of two o'clock

- 15 Section 4. This act shall take effect in 30 days.
