AN ACT

- 1 Providing for election day registration; and prescribing 2 penalties.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:

- 9 CHAPTER 1
- 10 PRELIMINARY PROVISIONS
- 11 Section 101. Short title.
- 12 This act shall be known and may be cited as the Election Day
- 13 Registration Act.
- 14 Section 102. Definitions.
- The following words and phrases when used in this act shall
- 16 have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- "Board" or "county board." The county board of elections.
- 19 "Department." The Department of State of the Commonwealth.
- 20 CHAPTER 3
- 21 ELECTION DAY REGISTRATION
- 22 Section 301. Election day registration.
- 23 (a) General rule. -- A person otherwise eligible to vote may
- 24 register to vote on the day of any primary, municipal or general
- 25 election by appearing in person at the polling place for the
- 26 election district in which the individual maintains residence,
- 27 completing a registration card, making an oath in the form
- 28 prescribed by the department and providing proof of residence.
- 29 (b) Proof of residence. -- An individual may prove residence
- 30 by any of the following methods:

- 1 (1) By displaying a valid driver's license.
- 2 (2) By showing any document approved by the department.
- 3 (3) By the written statement of an elector registered to
- 4 vote in that election district, sworn to in the presence of a
- 5 judge of elections, stating to the effect that the elector
- 6 personally knows that the individual is a resident of the
- 7 election district. An individual whose residence has been
- 8 sworn to under this paragraph on election day may not sign a
- 9 proof of residence oath for any other individual on that
- 10 election day.
- 11 Section 302. Procedure.
- 12 (a) Judges of elections. -- Voter registration under this act
- 13 shall be conducted by judges of elections. A judge who registers
- 14 an individual voter shall not process that voter's ballot at any
- 15 time prior to opening of the ballot box after the voting ends.
- 16 (b) Registration cards. -- Registration cards and forms for
- 17 oaths shall be available at each polling place. If an individual
- 18 who registers on election day proves residence under section
- 19 301(b)(3), the form containing that statement shall be attached
- 20 to the individual's registration card. Registration cards
- 21 completed on election day shall be forwarded to the appropriate
- 22 county board, which shall add the name of each voter to the
- 23 registration rolls unless the information forwarded is
- 24 substantially deficient. Each judge of elections registering a
- 25 person on election day shall initial the voter registration card
- 26 of that person.
- 27 (c) Deficient registration. -- A county board that finds an
- 28 election day registration substantially deficient shall mail
- 29 written notice of the same to the individual. An election day
- 30 registration shall not be found deficient solely because the

- 1 individual who provided proof of residence was ineligible to do
- 2 so.
- 3 Section 303. Maps.
- 4 The county board shall provide each polling place with a
- 5 detailed map showing election districts in order to assist
- 6 judges of elections in determining whether an address is located
- 7 in that district.
- 8 Section 304. Record of attempted registrations.
- 9 The judge of elections responsible for election day
- 10 registration at each polling place shall keep a record of the
- 11 number of individuals who attempt to register on election day
- 12 but who cannot provide proof of residence as required by this
- 13 act. This record shall be forwarded to the county board with the
- 14 election returns for that election district.
- 15 Section 305. Verification by mail.
- 16 Within 10 days of an election, each county board shall send a
- 17 notice to a random sampling of no less than 25% of individuals
- 18 registered on election day. The random sampling shall be
- 19 determined in accordance with the rules of the department. As
- 20 soon as practicable after the election, the board shall mail
- 21 registration verification notices to all individuals registered
- 22 on election day. If a notice is returned as not deliverable, the
- 23 board shall attempt to determine the reason for the return. A
- 24 county board which does not receive or obtain satisfactory proof
- 25 of an individual's eliqibility to vote shall immediately notify
- 26 the district attorney and the department.
- 27 CHAPTER 5
- 28 ENFORCEMENT AND PENALTIES
- 29 Section 501. Prohibited acts.
- 30 (a) Offenses enumerated.--It shall be unlawful:

- 1 (1) To cause an individual's name to be registered in
- 2 any election district if that individual is not eligible to
- 3 vote.
- 4 (2) To cause an individual's name to be registered for
- 5 the purpose of voting in more than one election district or
- 6 in any election district in which the individual does not
- 7 maintain residence.
- 8 (3) To misrepresent an individual's identity when
- 9 attempting to register to vote.
- 10 (4) To aid, abet, counsel or procure any other
- individual to violate this act.
- 12 (5) For a judge of elections to allow an unregistered
- voter to vote in any election.
- 14 (b) Grading. -- A violation of this section constitutes a
- 15 misdemeanor of the second degree.
- 16 Section 502. Enforcement.
- 17 Prosecution for violations of this act shall be brought by
- 18 the district attorney, upon information supplied by the
- 19 department, a county election officer or any person.
- 20 CHAPTER 11
- 21 MISCELLANEOUS PROVISIONS
- 22 Section 1101. Construction of act.
- 23 This act shall be construed as providing a procedure for
- 24 registration in addition to those methods as are provided by
- 25 law.
- 26 Section 1102. Rules and regulations.
- 27 The department shall, in the manner provided by law,
- 28 promulgate the rules and regulations necessary to carry out this
- 29 act.
- 30 Section 1103. Repeals.

- 1 All acts and parts of acts are repealed insofar as they are
- 2 inconsistent with this act.
- 3 Section 1104. Applicability.
- 4 This act shall apply to the municipal or general election
- 5 occurring in the year next following the year of final enactment
- 6 of this act and to each primary, municipal and general election
- 7 thereafter.
- 8 Section 1105. Effective date.
- 9 This act shall take effect immediately.
