AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- Consolidated Statutes, further providing for penalties for
- failure to report or to refer.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6319 of Title 23 of the Pennsylvania
- 7 Consolidated Statutes is repealed:
- 8 [§ 6319. Penalties for failure to report or to refer.
- 9 A person or official required by this chapter to report a
- 10 case of suspected child abuse or to make a referral to the
- 11 appropriate authorities who willfully fails to do so commits a
- 12 misdemeanor of the third degree for the first violation and a
- 13 misdemeanor of the second degree for a second or subsequent
- 14 violation.
- 15 Section 2. Title 23 is amended by adding a section to read:
- 16 \$ $\frac{6379}{6379.2}$. Penalties for failure to report or to refer.

- 1 (a) Failure to report or to refer. -- A person or official_
- 2 <u>required under this chapter SECTION 6311 (RELATING TO PERSONS</u>
- 3 REQUIRED TO REPORT SUSPECTED CHILD ABUSE) to report a case of
- 4 <u>suspected child abuse or to make a referral to the appropriate</u>
- 5 authorities who willfully fails to do so commits a misdemeanor
- 6 of the second degree.
- 7 (b) Interference with making report or referral. -- A person
- 8 who intentionally or knowingly prevents or interferes with the
- 9 <u>making of a report or referral of suspected child abuse BY A</u>
- 10 MANDATED REPORTER commits a misdemeanor of the first degree.
- 11 (c) Concealment of abuse to protect another. -- A person who
- 12 intentionally or knowingly acts to prevent the discovery under
- 13 this chapter of child abuse in order to protect or insulate any
- 14 person or entity from prosecution or liability commits a felony
- 15 of the third degree.
- 16 (d) Continuing course of action. -- If a person's willful
- 17 failure under subsection (a) continues while the person knows or
- 18 has reasonable cause to believe the child is actively being
- 19 abused, the person commits a felony of the third degree.
- 20 (e) Multiple offenses. -- A person who commits a second or
- 21 subsequent offense under subsection (a), (b), (c) or (d) commits
- 22 a felony of the second degree.
- 23 Section 2. This act shall take effect immediately.
- 24 SECTION 3. THIS ACT SHALL TAKE EFFECT JANUARY 1, 2014. <--
