AN ACT

- Amending the act of May 3, 1933 (P.L.242, No.86), entitled, as amended, "An act to promote the public health and safety by 2 providing for examination, licensing and granting of permits 3 for those who desire to engage in the profession of cosmetology; defining cosmetology, and regulating cosmetology 5 salons, schools, students, apprentices, teachers, managers, 6 manicurists and cosmetologists; conferring powers and duties 7 upon the Commissioner of Professional and Occupational 8 Affairs of the Department of State; providing for appeals to 9 certain courts by applicants and licensees; and providing 10 penalties," further providing for definitions and for 11 sanitary rules. 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 1 of the act of May 3, 1933 (P.L.242, 16 No.86), referred to as the Cosmetology Law, is amended by adding a definition to read: 17 18 Section 1. Definitions. -- The following words and phrases 19 when used in this act shall have the meanings given to them in 20 this section unless the context clearly indicates otherwise: 21 * * * 22 "Salon" means a licensed place, other than a school of
- 23 cosmetology, where cosmetology is practiced.

- 2 Section 2. Section 14 of the act is amended to read:
- 3 Section 14. Sanitary Rules. -- (a) The board shall prescribe
- 4 such sanitary rules as it may deem necessary, with particular
- 5 reference to the precautions necessary to be employed to prevent
- 6 the creating and spreading of infectious and contagious
- 7 diseases; and it shall be unlawful for the owner of any salon or
- 8 school of cosmetology to permit any person to sleep in or use
- 9 for residential purposes any room used wholly or in part as a
- 10 salon or school of cosmetology.
- 11 (b) Access to a lavatory for use by clients and employees
- 12 <u>must be provided within the building in which any salon is</u>
- 13 <u>located. The physical location of the lavatory need not be</u>
- 14 within the salon itself. Where a licensed salon establishment is
- 15 <u>located in or as a part of a home or other building containing</u>
- 16 <u>living quarters</u>, the portions thereof which are used for the
- 17 licensed practice of cosmetology may not be used as living,
- 18 <u>dining or sleeping quarters.</u>
- 19 Section 3. This act shall take effect in 60 days.
