- § 5501. Definitions. 14
- 15 The following words and phrases when used in this chapter
- shall have the meanings given to them in this section unless the 16
- context clearly indicates otherwise: 17
- "Shark fin." The raw, dried or otherwise processed detached 18

- 1 fin or the raw, dried or otherwise processed detached tail of a
- 2 member of the superorder selachimorpha. The term does not
- 3 <u>include a drug approved by the Food and Drug Administration of</u>
- 4 the Department of Health and Human Services of the United
- 5 States.
- 6 § 5502. Prohibition.
- 7 (a) Prohibition. -- Except as provided in subsection (b), a
- 8 person may not possess, sell, offer for sale, trade or
- 9 <u>distribute a shark fin.</u>
- 10 (b) Exceptions.--
- 11 (1) Possession of a shark fin is permissible if:
- 12 <u>(i) the shark was landed under a license from</u>
- 13 <u>another state; and</u>
- 14 <u>(ii) it is being possessed in this Commonwealth for</u>
- 15 <u>taxidermy</u>.
- 16 (2) Before September 1, 2015, a restaurant may possess,
- 17 sell, offer for sale, trade or distribute shark fin that:
- 18 (i) is prepared for consumption; and
- 19 (ii) the restaurant possesses prior to September 2,
- 20 2014.
- 21 § 5503. Penalty.
- 22 A person who violates section 5502 (relating to prohibition)
- 23 commits a summary offense. Each shark fin possessed, sold,
- 24 offered for sale or purchased in violation of section 5502 is a
- 25 separate offense.
- 26 Section 2. This act shall take effect in 60 days.
