AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 1 "An act concerning elections, including general, municipal, 2 special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating 4 and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; 7 imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 9 10 elections," in nomination of candidates, further providing 11 for number of signers required for nomination petitions of 12 candidates at primaries. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 912.1(32) of the act of June 3, 1937 17 (P.L.1333, No.320), known as the Pennsylvania Election Code, is 18 amended to read: 19 Section 912.1. Number of Signers Required for Nomination 20 Petitions of Candidates at Primaries. -- Candidates for nomination 21 of offices as listed below shall present a nominating petition 22 containing at least as many valid signatures of registered and

3	(32) [Office of district justice: One hundred.] <u>Office of</u>
4	magisterial district judge: One hundred, but only for a
5	candidate's primary election when the candidate does not already
6	hold the office of magisterial district judge. A sitting
7	magisterial district judge elected to the office shall not be
8	required to file a nominating petition under this section to run
9	for the office of magisterial district judge but may instead
10	file a certificate of nomination for reelection specifying the
11	intent to seek reelection to the office. IF A SITTING <
12	MAGISTERIAL DISTRICT JUDGE FILES A CERTIFICATE OF NOMINATION FOR
13	REELECTION, THE SITTING MAGISTERIAL DISTRICT JUDGE MAY NOT
14	CHALLENGE THE NOMINATING PETITION OF ANOTHER CANDIDATE FOR
15	MAGISTERIAL DISTRICT JUDGE.
