## A JOINT RESOLUTION

1 2 3	Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, in taxation and finance, further providing for exemptions and special provisions.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby resolves as follows:
6	Section 1. The following amendment to the Constitution of
7	Pennsylvania is proposed in accordance with Article XI:
8	That section 2(c) of Article VIII be amended to read:
9	§ 2. Exemptions and special provisions.
10	* * *
11	(c) Citizens and residents of this Commonwealth, who served
12	in any war or armed conflict in which the United States was
13	engaged and were honorably discharged or released under
14	honorable circumstances from active service, shall be exempt
15	from the payment of all real property taxes upon the residence
16	occupied by the said citizens and residents of this Commonwealth
17	imposed by the Commonwealth of Pennsylvania or any of its

political subdivisions if, as a result of military service, they 1 2 are blind, paraplegic or double or quadruple amputees or have a 3 service-connected disability declared by the United States Veterans Administration or its successor to be a total or 100% 4 permanent disability, and if the State Veterans' Commission 5 6 determines that such persons are in need of the tax exemptions 7 granted herein. This exemption shall be extended to the 8 unmarried surviving spouse upon the death of an eligible veteran provided that the State Veterans' Commission determines that 9 such person is in need of the exemption. This exemption shall 10 also be extended to the unmarried surviving spouse of a service 11 12 member who is killed or dies from injuries received while in 13 active service if the surviving spouse and the service member 14 owned and resided in the residence prior to the service member being called into active service and the State Veterans' 15 16 Commission determines that the unmarried surviving spouse is in 17 need of the exemption.

18 Section 2. (a) Upon the first passage by the General 19 Assembly of this proposed constitutional amendment, the 20 Secretary of the Commonwealth shall proceed immediately to 21 comply with the advertising requirements of section 1 of Article 22 XI of the Constitution of Pennsylvania and shall transmit the 23 required advertisements to two newspapers in every county in 24 which such newspapers are published in sufficient time after 25 passage of this proposed constitutional amendment.

(b) Upon the second passage by the General Assembly of this proposed constitutional amendment, the Secretary of the Commonwealth shall proceed immediately to comply with the advertising requirements of section 1 of Article XI of the Constitution of Pennsylvania and shall transmit the required

1 advertisements to two newspapers in every county in which such newspapers are published in sufficient time after passage of 2 this proposed constitutional amendment. The Secretary of the 3 Commonwealth shall submit this proposed constitutional amendment 4 to the qualified electors of this Commonwealth at the first 5 primary, general or municipal election which meets the 6 requirements of and is in conformance with section 1 of Article 7 XI of the Constitution of Pennsylvania and which occurs at least 8 three months after the proposed constitutional amendment is 9 10 passed by the General Assembly.
