AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in miscellaneous provisions, further providing for snow and ice dislodged or falling from moving vehicle. 3 The General Assembly of the Commonwealth of Pennsylvania 4 5 hereby enacts as follows: Section 1. Section 3720 of Title 75 of the Pennsylvania 6 Consolidated Statutes is amended to read: 7 § 3720. Snow and ice [dislodged or falling from moving 8 9 vehiclel. 10 (a) Removal of snow and ice from a motor vehicle or motor 11 carrier vehicle.--12 (1) Except as otherwise provided in this section, a 13 driver of a motor vehicle or motor carrier vehicle being 14 operated on a street or highway of this Commonwealth shall 15 make reasonable efforts to remove accumulated ice or snow 16 from the motor vehicle or motor carrier vehicle, including the hood, trunk and roof of the motor vehicle or motor 17 carrier vehicle, within 24 hours after the cessation of the 18

- falling snow or ice.
- 2 (2) Paragraph (1) shall not apply if:
- 3 <u>(i) the driver of the motor carrier vehicle is en</u>
- 4 route to a facility to remove accumulated ice or snow at
- 5 <u>the time of the stop under paragraph (3); or</u>
- 6 (ii) compliance with this section would cause the
- 7 <u>driver of the motor carrier vehicle to violate any other</u>
- 8 <u>Federal or State law or regulation regarding workplace</u>
- 9 <u>safety or would be a threat to the health and safety of</u>
- the driver.
- 11 (3) A driver of a motor vehicle or motor carrier vehicle
- 12 who violates this subsection may be stopped on a street or
- 13 <u>highway by a law enforcement officer if the law enforcement</u>
- officer believes the accumulated ice or snow may pose a
- threat to persons or property.
- 16 (4) A driver of a motor vehicle or motor carrier vehicle
- 17 who violates this subsection shall be subject to a fine of
- not less than \$25 nor more than \$75 for each offense
- 19 regardless of whether any snow or ice is dislodged from the
- 20 vehicle.
- 21 (b) Dislodged or fallen snow or ice.--When snow or ice is
- 22 dislodged or falls from a moving vehicle or motor carrier
- 23 vehicle and strikes another vehicle or pedestrian causing death
- 24 or serious bodily injury, the operator of the vehicle from which
- 25 the snow or ice is dislodged or falls and who is found in
- 26 violation of subsection (a) shall be subject to a fine of not
- 27 less than \$200 nor more than [\$1,000] \$1,500 for each offense.
- 28 SECTION 2. THIS AMENDATORY ACT SHALL BE KNOWN AS CHRISTINE'S <--

- 30 Section $\frac{2}{3}$. This act shall take effect in 60 days.
