AN ACT

1	Amending the act of May 1/, 1921 (P.L. 682, No. 284), entitled "Ar
2	act relating to insurance; amending, revising, and
3	consolidating the law providing for the incorporation of
4	insurance companies, and the regulation, supervision, and
5	protection of home and foreign insurance companies, Lloyds
6	associations, reciprocal and inter-insurance exchanges, and
7	fire insurance rating bureaus, and the regulation and
8	supervision of insurance carried by such companies,
9	associations, and exchanges, including insurance carried by
10	the State Workmen's Insurance Fund; providing penalties; and
11	repealing existing laws," providing for limits on copayments
12	for insured medical services provided by a physical
13	therapist, chiropractor and occupational therapist.
14	The General Assembly of the Commonwealth of Pennsylvania
15	hereby enacts as follows:
16	Section 1. The act of May 17, 1921 (P.L.682, No.284), known
17	as The Insurance Company Law of 1921, is amended by adding an
18	article to read:
19	ARTICLE X-B.
20	FAIRNESS IN MULTIPLE COPAYMENTS.
21	Section 1001-B. Declaration of intent.
22	The general purpose of this article is to provide fairness

- 1 for persons seeking appropriate MEDICALLY NECESSARY physical
- 2 therapy, chiropractic and occupational therapy who are sharing
- 3 the cost of the care pursuant to a health insurance policy by
- 4 prohibiting the imposition of multiple copayments for licensed
- 5 physical therapy, chiropractic and occupational therapy
- 6 <u>services.</u>
- 7 Section 1002-B. Definitions.
- 8 The following words and phrases when used in this article
- 9 shall have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Chiropractic." As defined in section 102 of the act of
- 12 December 16, 1986 (P.L.1646, No.188), known as the Chiropractic
- 13 Practice Act.
- 14 "Copayment." A specific dollar amount a covered person must
- 15 pay for services rendered by a provider under a health benefit
- 16 plan.
- 17 "Health insurance policy." As follows:
- 18 (1) An individual or group health insurance policy,
- 19 contract or plan that provides medical or health care
- 20 coverage by a health care facility or licensed health care
- 21 provider that is offered by or is governed under any of the
- 22 <u>following:</u>
- (i) This act.
- (ii) The act of December 29, 1972 (P.L.1701,
- No.364), known as the Health Maintenance Organization
- 26 Act.
- 27 (iii) 40 Pa.C.S. Ch. 61 (relating to hospital plan
- corporations).
- 29 (iv) 40 Pa.C.S. Ch. 63 (relating to professional
- health services plan corporations).

- 1 (2) The term does not include accident only, fixed
- 2 indemnity, limited benefit, credit, dental, vision, specified
- 3 <u>disease, Medicare supplement, Civilian Health and Medical</u>
- 4 Program of the Uniformed Services (CHAMPUS) supplement, long-
- 5 <u>term care or disability income, workers' compensation or </u>
- 6 <u>automobile medical payment insurance.</u>
- 7 <u>"Occupational therapy."</u> As defined in section 3 of the act
- 8 of June 15, 1982 (P.L.502, No.140), known as the Occupational
- 9 <u>Therapy Practice Act.</u>
- 10 "Physical therapy." As defined in section 2 of the act of
- 11 October 10, 1975 (P.L.383, No.110), known as the Physical
- 12 <u>Therapy Practice Act.</u>
- 13 <u>Section 1003-B. Limits on copayments.</u>
- 14 <u>A health insurance policy that is delivered, issued for</u>
- 15 <u>delivery</u>, renewed, extended or modified in this Commonwealth by
- 16 <u>a health care insurer for services provided by a licensed</u>
- 17 physical therapist, chiropractor and OR occupational therapist <--
- 18 provider may not subject an insured to more than one copayment
- 19 amount per visit or deplete more than one visit WITH ANY ONE <-
- 20 PROVIDER.
- 21 Section 1004-B. Regulations.
- The department may promulgate regulations as may be necessary
- 23 or appropriate to carry out the provisions of this article.
- 24 Section 1005-B. Penalties.
- 25 <u>A violation of this article by an insurer if committed</u>
- 26 flagrantly and in conscious disregard of the provisions of this
- 27 <u>article or with frequency sufficient to constitute a general</u>
- 28 business practice shall be considered a violation of the act of
- 29 July 22, 1974 (P.L.589, No.205), known as the Unfair Insurance
- 30 Practices Act. A violation of this article is deemed an unfair

- 1 method of competition and an unfair deceptive act or practice
- 2 pursuant to the Unfair Insurance Practices Act.
- 3 Section 1006-B. Applicability.
- 4 This article shall apply as follows:
- 5 (1) For health insurance policies for which either rates
- or forms are required to be filed with the Federal Government
- 7 or the Insurance Department, this article shall apply to any
- 8 policy for which a form or rate is first filed on or after
- 9 <u>the effective date of this section.</u>
- 10 (2) For health insurance policies for which neither
- 11 rates nor forms are required to be filed with the Federal
- 12 Government or the Insurance Department, this article shall
- apply to any policy issued or renewed on or after 180 days
- 14 after the effective date of this section.
- 15 Section 2. This act shall take effect in 60 days.
