AN ACT

- Amending the act of October 27, 1955 (P.L.744, No.222), entitled "An act prohibiting certain practices of discrimination 2 because of race, color, religious creed, ancestry, age or 3 national origin by employers, employment agencies, labor organizations and others as herein defined; creating the Pennsylvania Human Relations Commission in the Governor's 6 7 Office; defining its functions, powers and duties; providing for procedure and enforcement; providing for formulation of 8 an educational program to prevent prejudice; providing for 9 10 judicial review and enforcement and imposing penalties," further providing for definitions. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. The definitions of "employe" and "independent 15 contractor" in section 4 of the act of October 27, 1955 16 (P.L.744, No.222), known as the Pennsylvania Human Relations 17 Act, are amended to read: 18 Section 4. Definitions. -- As used in this act unless a different meaning clearly appears from the context: 20 21 The term "employe" [does not include (1) any individual
- 22 employed in agriculture or in the domestic service of any

- 1 person, (2) any individuals who, as a part of their employment,
- 2 reside in the personal residence of the employer, (3) any
- 3 individual employed by said individual's parents, spouse or
- 4 child.] means an individual subject to an employer's power to
- 5 control the nature and parameters of the individual's
- 6 <u>activities</u>, including hiring, firing, training, scheduling,
- 7 <u>directing work and proscribing the manner in which the work</u>
- 8 should be completed. The term does not include:
- 9 (1) an individual who is employed by and who works on a
- 10 casual basis in a home or personal residence of another
- 11 individual; or
- 12 (2) an individual employed by the individual's parent,
- 13 spouse or child.

- 15 (x) The term "independent contractor" includes:
- 16 (1) any person who is subject to the provisions governing
- 17 any of the professions and occupations regulated by State
- 18 licensing laws enforced by the Bureau of Professional and
- 19 Occupational Affairs in the Department of State, or is included
- 20 in the Fair Housing Act (Public Law 90-284, 42 U.S.C. § 3601 et
- 21 seq.)[.]; or
- (2) any person, other than an employe, who performs a
- 23 <u>service for remuneration under a contract, written or oral,</u>
- 24 express or implied, for an employer.

- 26 Section 2. This act shall take effect in 60 days.
