## AN ACT

- Amending the act of July 7, 1980 (P.L.380, No.97), entitled "An 1 act providing for the planning and regulation of solid waste 2 storage, collection, transportation, processing, treatment, and disposal; requiring municipalities to submit plans for municipal waste management systems in their jurisdictions; authorizing grants to municipalities; providing regulation of 6 the management of municipal, residual and hazardous waste; requiring permits for operating hazardous waste and solid waste storage, processing, treatment, and disposal 9 facilities; and licenses for transportation of hazardous 10 waste; imposing duties on persons and municipalities; 11 granting powers to municipalities; authorizing the 12 13 Environmental Quality Board and the Department of Environmental Resources to adopt rules, regulations, 14 standards and procedures; granting powers to and imposing duties upon county health departments; providing remedies; prescribing penalties; and establishing a fund," in residual 15 16 17 18 waste, further providing for transportation of residual waste; and abrogating a regulation. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 Section 1. Section 303 of the act of July 7, 1980 (P.L.380, <--No.97), known as the Solid Waste Management Act, is amended by 24 adding subsections to read:
- 25 Section 303. Transportation of residual waste.

- 2 (c) The department may not prohibit the vehicular
- 3 transportation of leachate discharged from a collection and
- 4 handling system of a landfill to an offsite facility for the
- 5 treatment of the leachate.
- 6 (d) Definition. As used in this section, the term
- 7 "Leachate" means as defined in 25 Pa. Code § 271.1 (relating to
- 8 definitions).
- 9 Section 2. The regulations of the Department of
- 10 Environmental Protection in 25 Pa. Code § 273.273(a), (b) (1),
- 11 (2) and (3) and (e) (relating to leachate transportation) are
- 12 <del>abrogated.</del>
- 13 Section 3. This act shall take effect in 60 days.
- 14 SECTION 1. SECTION 303 OF THE ACT OF JULY 7, 1980 (P.L.380, <--
- 15 NO.97), KNOWN AS THE SOLID WASTE MANAGEMENT ACT, IS AMENDED BY
- 16 ADDING SUBSECTIONS TO READ:
- 17 SECTION 303. TRANSPORTATION OF RESIDUAL WASTE.
- 18 \* \* \*
- 19 (C) THE DEPARTMENT MAY NOT PROHIBIT OR PENALIZE THE
- 20 <u>VEHICULAR TRANSPORTATION OF LEACHATE DISCHARGED FROM A</u>
- 21 COLLECTION AND HANDLING SYSTEM OF A LANDFILL TO AN OFFSITE
- 22 FACILITY FOR THE TREATMENT OF THE LEACHATE, PROVIDED THAT:
- 23 (1) TRUCKING OF LEACHATE MAY BE CONDUCTED USING VEHICLES
- 24 WITH ENCLOSED TANKS IF THEY ARE OPERATED IN COMPLIANCE WITH
- 25 ALL APPLICABLE REGULATIONS PROMULGATED BY THE FEDERAL MOTOR
- 26 CARRIER SAFETY ADMINISTRATION REGULATIONS UNDER 49 CFR
- 27 (RELATING TO TRANSPORTATION).
- 28 (2) IF THE DAILY NUMBER OF TANKER VEHICLES TRANSPORTING
- 29 LEACHATE WILL BE GREATER THAN 10% OF THE TOTAL NUMBER OF
- 30 VEHICLES DELIVERING WASTE AND MATERIALS TO THE SITE AS

- 1 EVALUATED IN THE MOST RECENT TRAFFIC STUDY FOR THE FACILITY,
- 2 A NEW TRAFFIC IMPACT ANALYSIS SHALL BE CONDUCTED AND REVIEWED
- 3 PURSUANT TO APPLICABLE REGULATIONS OF THE DEPARTMENT OF
- 4 TRANSPORTATION. THE FACILITY MAY BE REQUIRED TO SUBMIT AN
- 5 UPDATED ENVIRONMENTAL ASSESSMENT THAT INCLUDES THE NEW
- 6 TRAFFIC IMPACT ANALYSIS TO THE DEPARTMENT FOR ITS
- 7 CONSIDERATION IN ACCORDANCE WITH 25 PA. CODE §§ 271.126
- 8 (RELATING TO REQUIREMENT FOR ENVIRONMENTAL ASSESSMENT) AND
- 9 271.127 (RELATING TO ENVIRONMENTAL ASSESSMENT).
- 10 (3) TO THE EXTENT AN EXISTING PERMITTED LANDFILL, OR
- 11 EXPANSION THEREOF, PROPOSES TO USE LEACHATE TRANSPORTATION AS
- 12 A BASIC TREATMENT METHOD FOR SOME OR ALL OF THE DAILY VOLUME
- 13 OF LEACHATE CALCULATED PURSUANT TO 25 PA. CODE § 273.162(A)
- 14 (1) (RELATING TO LEACHATE TREATMENT PLAN), THE FACILITY
- 15 CLOSURE AND POST CLOSURE FINANCIAL ASSURANCE SHALL BE
- 16 RECALCULATED AND INCREASED, IF REQUIRED, TO COVER THE COSTS
- 17 ASSOCIATED WITH THAT VOLUME AND DURATION OF THE PROPOSED
- 18 LEACHATE TRANSPORTATION. NO FINANCIAL ASSURANCE MODIFICATION
- 19 SHALL BE REQUIRED FOR THE USE OF TRANSPORTATION FOR
- 20 MANAGEMENT OF LEACHATE VOLUMES RELATED TO EXCESS RAINFALL,
- 21 OPEN CELL CONDITIONS, SYSTEM INTERRUPTIONS OR EMERGENCIES.
- 22 (D) AS USED IN THIS SECTION, THE TERM "LEACHATE" MEANS AS
- 23 <u>DEFINED IN 25 PA. CODE § 271.1 (RELATING TO DEFINITIONS).</u>
- 24 SECTION 2. THE REGULATIONS OF THE DEPARTMENT OF
- 25 ENVIRONMENTAL PROTECTION IN 25 PA. CODE §§ 273.163(B) AND
- 26 273.273(A), (B)(1), (2) AND (3) AND (E) ARE ABROGATED.
- 27 SECTION 3. THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
