## AN ACT

- The General Assembly of the Commonwealth of Pennsylvania 9
- 10 hereby enacts as follows:
- Section 1. Sections 3201, 3202(a) introductory paragraph and 11
- 12 (1), (b) and (c) introductory paragraph, (4) and (5) and 3204 of
- 13 Title 51 of the Pennsylvania Consolidated Statutes are amended

- § 3201. Definitions. 15
- The following words and phrases when used in this subchapter 16
- 17 shall have the meanings given to them in this section unless the
- context clearly indicates otherwise: 18
- 19 "Agency." The Pennsylvania Higher Education Assistance

- 1 Agency.
- 2 "Annual tuition rate." The in-State tuition rate, including
- 3 a technology tuition fee, established or approved by May 1 of
- 4 <u>each year by the Board of Governors of the State System of</u>
- 5 Higher Education.
- 6 "Approved institution of higher learning." An educational
- 7 institution offering a post-secondary program of education
- 8 located in this Commonwealth and approved by the [Pennsylvania
- 9 Higher Education Assistance Agency] agency.
- "Approved program of education." A [degree-] degree-granting
- 11 or certificate-granting curriculum [or course of study], course
- 12 of study or training required for entrance into a specific
- 13 <u>career</u> to be pursued on a full-time or part-time basis or its
- 14 equivalent as determined by the [Pennsylvania Higher Education
- 15 Assistance Agency] agency, at an approved institution of higher
- 16 learning.
- 17 ["Combat zone." An area designated by Presidential executive
- 18 order as a combat zone as described in section 7508 of the
- 19 Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. §
- 20 7508).]
- 21 <u>"Certificate of eliqibility." A certificate from the</u>
- 22 department that certifies a member's eligibility for an
- 23 educational assistance grant.
- 24 "Costs of attendance." Allowable educational expenses, as
- 25 determined by the agency, that are consistent with the
- 26 administration of the act of January 25, 1966 (1965 P.L.1546,
- 27 No.541), referred to as the Higher Education Scholarship Law.
- 28 <u>"Educational assistance." A benefit earned which shall be</u>
- 29 given to an eligible member who has complied with all of the
- 30 requirements provided for under this subchapter.

- 1 "Eligible member." A member of the Pennsylvania National
- 2 Guard who meets the criteria specified in section 3202 (relating
- 3 to eligibility) and who has been awarded a certificate of
- 4 eligibility under section 3203 (relating to certification of
- 5 eligibility).
- 6 "Full-time student." [A student] An eligible member enrolled
- 7 in an approved institution of higher learning pursuing an
- 8 approved program of education equal to or greater than [15] 12
- 9 credit hours <u>per semester</u> or its equivalent <u>that is</u> recognized
- 10 by the [Pennsylvania Higher Education Assistance Agency] agency
- 11 as a full-time course of study.
- 12 "Fund." The Educational Assistance Program Fund.
- "Part-time student." [A student] An eligible member enrolled
- 14 in an approved institution of higher education pursuing an
- 15 approved program of education of less than [15]  $\underline{12}$  credit hours
- 16 <u>per semester</u> or its equivalent <u>that is</u> recognized by the
- 17 [Pennsylvania Higher Education Assistance Agency] agency as a
- 18 part-time course of study.
- 19 "Program." The Educational Assistance Program [established
- 20 in this subchapter].
- 21 ["Qualified resident." An individual who has been a bona
- 22 fide resident of this Commonwealth prior to the time an
- 23 application for a grant is made. The Pennsylvania Higher
- 24 Education Assistance Agency shall make the final decision on
- 25 whether an applicant is a qualified resident.]
- 26 <u>"Promissory note." A written contract signed by a member of</u>
- 27 the Pennsylvania National Guard in which the member promises to
- 28 repay the awarded grant amount.
- 29 "Technology tuition fee." A separate tuition fee established
- 30 by the Board of Governors of the State System of Higher

- 1 Education for rendering technology resources and services to
- 2 <u>enhance student learning experiences.</u>
- 3 § 3202. Eligibility.
- 4 (a) General rule. -- A <u>member of the</u> Pennsylvania National
- 5 Guard [member] is eligible to receive [a public service
- 6 educational] <u>an educational assistance</u> grant under this
- 7 subchapter if the member meets all of the following eligibility
- 8 criteria:
- 9 [(1) The member is a qualified resident of this
- 10 Commonwealth.]
- 11 \* \* \*
- 12 (b) Additional eligibility criteria for full-time [student
- 13 assistance] educational assistance grants. -- In addition to the
- 14 eligibility criteria specified in subsection (a), [a student] an
- 15 <u>eliqible member</u> must meet the following eliqibility criteria to
- 16 qualify for a full-time [student assistance] educational
- 17 <u>assistance</u> grant:
- 18 (1) The member does not possess a baccalaureate degree.
- 19 (2) The member accepts an obligation to serve in the
- 20 Pennsylvania National Guard for a period of six years [from <

- the date fof entry into the program by enlistment,
- reenlistment, extension of enlistment or execution of a
- 23 service commitment] the member signs a promissory note.
- 24 (3) The member has enrolled as a full-time student in an
- approved program of education at an approved institution of
- 26 higher learning.
- 27 (4) The member is not receiving a Reserve Officer
- Training Corps (ROTC) Scholarship, excluding a Guaranteed
- 29 Reserve Forces Duty Scholarship.
- 30 (c) Discharge for disability incurred in the line of duty.--

- 1 A [Pennsylvania National Guard] member who is discharged for
- 2 medical disability after September 11, 2001, shall remain
- 3 eligible to receive [a public service educational] an
- 4 <u>educational assistance</u> grant under this subchapter if the member
- 5 meets all of the following eligibility criteria:
- 6 \* \* \*
- 7 (4) The former member received an [honorable] other than 8 dishonorable discharge for medical reasons.
- 9 (5) The former member [had] accepted an obligation to 10 serve in the Pennsylvania National Guard [for a minimum
- period of service established by the Adjutant General] <del>by</del>
- 12 <u>signing a promissory note</u> and was qualified to [have
- fulfilled such] <u>fulfill the</u> service obligation but for the
- 14 medical disability that resulted in discharge.

- 16 § 3204. Grants.
- 17 (a) General rule. -- From the funds appropriated for the
- 18 purposes of this subchapter, grants shall be provided to
- 19 eligible members for the purpose of pursuing approved programs
- 20 of education. An educational assistance grant shall be treated
- 21 as a benefit earned by an eliqible member for honorable service
- 22 to the country and this Commonwealth.
- 23 (b) Promissory notes. -- [At] <u>Upon</u> the receipt of the grant,
- 24 an eliqible member shall siqn a promissory note obliqating the
- 25 <u>eliqible member</u> to repay the full amount of the grant[. The
- 26 promissory note shall be conditional upon noncompletion of] if
- 27 the eliqible member fails to fulfill the service obligation
- 28 under section 3207(a) (relating to recoupment of grant
- 29 payments).
- 30 Section 2. Sections 3205(a), (b), (b.1) and (c) and 3206(a)

- 4 (a) Full-time [student assistance] <u>educational assistance</u>
- 5 grants. -- Grants awarded under this subchapter to full-time

- 8 lesser of:
- 9 (1) the tuition <u>rate</u> of the approved institution of
- 10 higher learning for the number of credit hours per semester
- 11 <u>or its equivalent</u> for the approved program of education in

- 13 (2) the annual tuition rate charged [to a resident of

- 28 <u>may or may not possess a baccalaureate degree shall be</u>

  22 agency grants or aid for which the eligible member qualifies

    subchapter, the approved institution of higher learning shall first consider any Federal tuition assistance received by the eligible member and then shall award a grant under this [chapter] subchapter if the eligible member requires additional financial aid to cover the costs of attendance for

- 3 eligible member for approved costs of attendance. Grants
- 4 authorized under this [section] <u>subchapter</u> shall be reduced

- 6 benefits, as administered by the Pennsylvania National Guard,
- 7 do not exceed 100% of the costs of attendance.

- 29 (3) When an eligible member withdraws from a program of

- (2) For eligible members who were called or ordered to active Federal service or active State duty under section 508 (relating to active State duty for emergency) after September 11, 2001, the deadline for making grant payments shall be extended for one additional month for each month or part of month of such service after the eligible member is discharged or released under [honorable] other than dishonorable conditions from the Pennsylvania National Guard.
  - (3) For <u>eligible</u> members discharged because of a disability incurred in the line of duty who are eligible under section 3202(c) (relating to eligibility), the deadline for making grant payments shall be:
    - (i) Six years after the <u>eligible</u> member's medical discharge for members discharged for a medical disability on or after the effective date of this paragraph unless extended under section 3202 (c)(6).
- (ii) Six years following the effective date of this paragraph for <u>eligible</u> members discharged for a medical disability after September 11, 2001, and before the effective date of this paragraph unless extended under section 3202 (c) (6).
- 27 (c) Limit on tuition. -- At no time may a State System of
- 28 Higher Education institution charge an eligible member more than
- 29 the in-State rate.
- 30 Section 3. Sections 3207, 3208, 3209 and 3210 of Title 51

- 2 § 3207. Recoupment of grant payments.
- 3 (a) General rule. -- An eligible member who fails to meet the

- 25 in subsection (a)(2) shall remain eligible to receive a Military
- 26 Family Education Program grant under this subchapter if the
- 27 <u>eligible member met the following eligibility criteria at the</u>
- 28 time of death:
- 29 (1) The deceased eligible member was in good standing
- 30 with the Pennsylvania National Guard.

- 1 (2) The deceased eligible member was eligible for an
- 2 <u>other than dishonorable discharge.</u>
- 3 (3) The deceased eligible member had accepted an
- 4 <u>obligation to serve in the Pennsylvania National Guard <del>by</del></u>
- 5 <u>signing a promissory note</u> and was qualified to fulfill the
- 6 service obligation but for the eligible member's death.
- 7 (4) Upon an eligible member's death, if the eligible
- 8 <u>member has not assigned the family member or family members</u>
- 9 <u>to receive the Military Family Education Program grant as</u>
- 10 provided for under this subchapter, the next of kin shall
- designate the family member or family members to receive the
- 12 <u>Military Family Education Program grant.</u>
- 13 § 3210.3. Certification of eligibility.
- 14 The department shall certify members of the Pennsylvania
- 15 National Guard who meet the eligibility criteria set forth in
- 16 section 3210.2 (relating to eligibility) as eligible to
- 17 participate in the Military Family Education Program and shall
- 18 provide the agency with a certificate of eligibility for each
- 19 eligible family member.
- 20 § 3210.4. Military Family Education Program grants.
- 21 (a) General rule. -- From the funds appropriated for the
- 22 purposes of this subchapter, Military Family Education Program
- 23 grants shall be provided to eligible family members for the
- 24 purpose of pursuing an approved program of education. A Military
- 25 Family Education Program grant shall be treated as a benefit
- 26 earned by an eliqible member for honorable service to the
- 27 <u>country and this Commonwealth.</u>
- 28 (b) Promissory note.--Prior to entry into the Military
- 29 Family Education Program the eligible member shall sign a
- 30 promissory note obligating the eligible member to repay the full

- 1 amount of the family member's Military Family Education Program
- 2 grant if the eligible member fails to satisfactorily fulfill the
- 3 <u>eligible member's obligation. The promissory note shall become</u>
- 4 payable upon noncompletion of the service obligation under
- 5 <u>section 3210.7(a)</u> (relating to recoupment of Military Family
- 6 Education Program grant payments).
- 7 § 3210.5. Amount of Military Family Education Program grants.
- 8 (a) Full-time Military Family Education Program grant.--
- 9 Military Family Education Program grants awarded under this
- 10 subchapter to full-time students shall be determined by the
- 11 agency without regard to financial need and shall not exceed for
- 12 <u>each academic year the lesser of:</u>
- 13 (1) the tuition rate of the approved institution of
- higher learning for the number of credit hours per semester
- or its equivalent for the approved program of education in
- which the family member is enrolled; or
- 17 (2) the annual tuition rate charged by a State System of
- 18 Higher Education institution for the academic year.
- 19 (b) Part-time Military Family Education Program grants.--
- 20 Military Family Education Program grants awarded under this
- 21 subchapter to part-time students who may or may not possess a
- 22 baccalaureate degree shall be determined by the agency without
- 23 regard to financial need and shall not exceed for each academic
- 24 year or period the lesser of:
- 25 (1) the tuition charged by the approved institution of
- higher learning for the number of credit hours per semester
- or its equivalent in which the family member is enrolled; or
- 28 (2) the annual tuition rate charged by a State System of
- 29 Higher Education institution for the number of credit hours
- 30 per semester or its equivalent in which the family member is

- 1 <u>enrolled for the same academic year or period.</u>
- 2 (c) Other grants and financial aid. --
- 3 (1) The agency shall not reduce the amount of other
- 4 agency grants or aid for which the family member qualifies on
- 5 account of the family member's eligibility for or receipt of
- 6 <u>a Military Family Education Program grant under this</u>
- 7 <u>subchapter</u>.
- 8 (2) Prior to making a Military Family Education Program
- grant under this subchapter, the approved institution of
- 10 higher learning shall first consider any Federal tuition
- 11 <u>assistance received by the family member and then shall award</u>
- 12 <u>a Military Family Education Program grant under this</u>
- 13 <u>subchapter if the family member requires additional financial</u>
- 14 <u>aid to cover the costs of attendance for an approved program</u>
- of higher education. A Military Family Education Program
- grant under this subchapter shall be paid or refunded to the
- family member for approved costs of attendance. Military
- 18 Family Education Program grants authorized under this section
- 19 shall be reduced so that the total of all Federal and State
- 20 military education benefits, as administered by the
- 21 Pennsylvania National Guard, does not exceed 100% of the
- 22 costs of attendance.
- 23 (d) Adjustments.--If the agency and the Adjutant General
- 24 determine that the amount appropriated for the Military Family
- 25 Education Program in any year will be insufficient to provide
- 26 Military Family Education Program grants in the amounts set
- 27 forth in this section to all family members, the agency and the
- 28 department may reduce the maximum amount of the Military Family
- 29 Education Program grants proportionately or set a limit on the
- 30 number of participants to ensure that sums expended do not

- 1 exceed appropriations.
- 2 (e) Limit on charges. -- Family members attending a State
- 3 System of Higher Education institution shall not be charged
- 4 <u>additional tuition above the annual tuition rate.</u>
- 5 (f) Limit on tuition. -- At no time may a State System of
- 6 <u>Higher Education institution charge a family member more than</u>
- 7 the in-State rate.
- 8 § 3210.6. Limitations.
- 9 <u>(a) General rule.--No eligible member shall be permitted to</u>
- 10 assign more than five academic years or their equivalent, as
- 11 <u>determined by the agency.</u>
- 12 <u>(b) Assignment of benefit.--An eligible member may assign a</u>
- 13 portion of the entire benefit or the entire benefit by the
- 14 <u>number of credit hours per semester or its equivalent, as</u>
- 15 determined by the agency, to one or more family members, as the
- 16 case may be.
- 17 § 3210.7. Recoupment of Military Family Education Program grant
- payments.
- 19 (a) General rule. -- An eligible member who fails to meet the
- 20 six-year service obligation of this subchapter or to meet other
- 21 requirements established by the Adjutant General or the agency
- 22 is liable to the Commonwealth for repayment of all or part of
- 23 Military Family Education Program grant payments made. The
- 24 Adjutant General shall notify the agency if an eliqible member
- 25 fails to complete the service obligation and the promissory note
- 26 under section 3210.4(b) (relating to Military Family Education
- 27 Program grants) shall be repaid by the eligible member upon
- 28 demand of the agency on a schedule as the agency may determine.
- 29 (b) Forgiveness of recoupment.--Upon notification by the
- 30 Adjutant General, the agency shall forgive recoupment of all or

- 1 part of a family member's Military Family Education Program
- 2 grant payments if the Adjutant General determines that the
- 3 <u>eligible member's failure to fulfill the six-year service</u>
- 4 <u>obligation</u> is the result of one of the following:
- 5 (1) The eliqible member's death. If all provisions in
- 6 <u>section 3210.2(c) (relating to eligibility) are not met, the</u>
- 7 <u>Military Family Education Program grant shall be repaid by</u>
- 8 the family member or family members who used the benefit upon
- 9 <u>demand of the agency on a schedule as the agency may</u>
- determine.
- 11 (2) The eligible member's discharge because of
- 12 <u>disability incurred in the line of duty.</u>
- 13 (3) The eligible member's discharge because of a medical
- 14 <u>determination that the eligible member is medically unfit for</u>
- 15 <u>duty when the medical condition is outside the eligible</u>
- member's control and is not due to the eligible member's
- 17 misconduct or discharge.
- 18 (4) The existence of other compelling circumstances that
- 19 warrant forgiveness.
- 20 § 3210.8. Regulations.
- 21 The Adjutant General and the agency may promulgate
- 22 regulations to carry out the provisions of this chapter.
- 23 § 3210.9. Administration.
- 24 (a) Appropriation and administrative costs.--The General
- 25 Assembly shall appropriate funds to pay full-time and part-time
- 26 Military Family Education Program grants under this subchapter.
- 27 A portion of the funds appropriated may be used to pay the costs
- 28 of the administration of this subchapter.
- 29 (b) Limitation.--Administrative costs for the fiscal year in
- 30 which the Military Family Education Program is enacted, and each

- 1 fiscal year thereafter, shall not exceed 3.5% of the total
- 2 amount of funds appropriated.
- 3 (c) Initial use of funds.--Initial funding for the first 12-
- 4 month period from the effective date of this subchapter may be
- 5 <u>used for administration and development of technological support</u>
- 6 <u>applications</u>.
- 7 § 3210.10. Military Family Education Program Fund.
- 8 (a) Establishment. -- The Military Family Education Program
- 9 Fund is established as a special nonlapsing fund in the State
- 10 Treasury.
- 11 (b) Appropriation. -- All money deposited into the fund and
- 12 the interest the fund accrues are appropriated to the department
- 13 on a continuing basis to be used for the purposes provided for
- 14 <u>under this subchapter.</u>
- 15 (c) Administrative action prohibited. -- No administrative
- 16 action shall prevent the deposit of money into the fund in the
- 17 fiscal year in which the money is received.
- 18 (d) Use. -- The fund may only be used for the purposes
- 19 provided for under this subchapter and no money in the fund may
- 20 be transferred or diverted to any other purpose by
- 21 administrative action.
- 22 Section 5. This act shall take effect as follows:
- 23 (1) The addition of 51 Pa.C.S. § 3210.2(a)(1) and (2)
- shall take effect July 1, 2019.
- 25 (2) The addition of 51 Pa.C.S. § 3210.2(a)(3), (4) and
- 26 (5) shall take effect August 1, 2020.
- 27 (3) The remainder of this act shall take effect
- 28 immediately.
