1 2 3 4	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in theft and related offenses, providing for the offense of theft of prescriptions or prescription order forms.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 18 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	§ 3935. Theft of prescriptions or prescription order forms.
10	(a) Offense defined A person commits the offense of theft
11	of prescriptions or prescription order forms if he:
12	(1) unlawfully takes possession of or exercises control
13	over a prescription or prescription order form for a
14	controlled substance or other drug prescribed by a
15	practitioner for an ultimate user with the intent to deprive
16	the ultimate user of the use of the controlled substance; or
17	(2) unlawfully takes possession of or exercises control
18	over blank prescriptions or prescription order forms for a

- 1 controlled substance or other drug used by a practitioner for
- 2 purposes of prescribing controlled substances with the intent
- 3 to deprive the practitioner of the blank prescriptions or
- 4 <u>prescription order forms.</u>
- 5 (b) Grading.--An offense under this section constitutes a
- 6 <u>felony of the third degree.</u>
- 7 (c) Definitions.--As used in this section, the following
- 8 words and phrases shall have the meanings given to them in this
- 9 subsection:
- 10 "Controlled substance." As defined in the act of April 14,
- 11 1972 (P.L.233, No.64), known as The Controlled Substance, Drug,
- 12 <u>Device and Cosmetic Act.</u>
- 13 "Drug." As defined in the act of April 14, 1972 (P.L.233,
- 14 No.64), known as The Controlled Substance, Drug, Device and
- 15 Cosmetic Act.
- 16 "Practitioner." As defined in the act of April 14, 1972
- 17 (P.L.233, No.64), known as The Controlled Substance, Drug,
- 18 Device and Cosmetic Act.
- 19 "Prescription" or "prescription order." As defined in the
- 20 act of April 14, 1972 (P.L.233, No.64), known as The Controlled
- 21 Substance, Drug, Device and Cosmetic Act.
- 22 "Ultimate user." As defined in the act of April 14, 1972
- 23 (P.L.233, No.64), known as The Controlled Substance, Drug,
- 24 Device and Cosmetic Act.
- 25 Section 2. This act shall take effect in 60 days.
