- 2 Section 101. Short title.
- 3 This act shall be known and may be cited as the Second
- 4 Supplement to the General Appropriation Act of 2020.
- 5 Section 102. Definitions.
- 6 The definitions in the act of May 29, 2020 (P.L., No.1A),
- 7 known as the General Appropriation Act of 2020, shall apply to
- 8 this act.
- 9 Section 103. Abbreviations.
- 10 The abbreviations in the act of May 29, 2020 (P.L., No.1A),
- 11 known as the General Appropriation Act of 2020, shall apply to
- 12 this act.
- 13 Section 104. State appropriations.
- 14 (a) General Fund. -- The sums specified in this act, or as
- 15 much thereof as may be necessary, are specifically appropriated
- 16 from the General Fund to agencies of the Executive Department of
- 17 the Commonwealth for the payment of salaries, wages or other
- 18 compensation and travel expenses of the duly elected or
- 19 appointed officers and employees of the Commonwealth, for the
- 20 payment of fees for contractual services rendered, for the
- 21 purchase or rental of goods and services, printing, public
- 22 advertising by or through any medium, equipment, land and
- 23 buildings and for payment of any other expenses, as provided by
- 24 law or by this act, necessary for the proper conduct of the
- 25 duties, functions and activities and for the purposes specified
- 26 in this act for the current fiscal year.
- 27 (b) (Reserved).
- 28 Section 105. Federal appropriations.
- 29 The Federal appropriations specified in this act, or as much
- 30 thereof as may be necessary, are specifically appropriated to

- 1 the agencies of the Executive Department of the Commonwealth
- 2 specified in this act for the payment of the expenses of
- 3 implementing and carrying out the programs specified in this act
- 4 for the current fiscal year. Unless otherwise stated, the
- 5 Federal appropriations include any carryovers from the prior
- 6 fiscal year.

- 12 Section 201. Construction with other appropriation acts.
- 13 All appropriations contained in this part from the General
- 14 Fund shall be in addition to any appropriation under the act of
- 15 May 29, 2020 (P.L., No.1A), known as the General Appropriation
- 16 Act of 2020, and the act of November 23, 2020 (P.L., No. 17A),
- 17 known as the Supplement to the General Appropriation Act of
- 18 2020.

- 8 Section 6101. General Fund repository for Federal funds.
- 9 Money received from the Federal Government as contributions
- 10 or supplements to the departments or agencies of the
- 11 Commonwealth or the programs provided in this act shall be paid
- 12 into the General Fund.
- 13 Section 6102. (Reserved).
- 14 Section 6103. Appropriation of prior unspent Federal funds.
- 15 (a) General rule. -- Federal moneys that have been previously
- 16 appropriated by the General Assembly and authorized or allocated
- 17 by the Federal Government but remain unspent from the prior
- 18 fiscal year or previous fiscal years and will not be renewed for
- 19 the current fiscal year are appropriated.
- 20 (b) Department of Human Services. -- The Federal
- 21 appropriations to the Department of Human Services include any
- 22 prior earnings that may be received during the current fiscal
- 23 year. In addition to the amounts specifically appropriated in
- 24 this act to the Department of Human Services, all money
- 25 appropriated from the Federal Government during a previous
- 26 fiscal year which are expected to be received as reimbursements
- 27 may be carried forward until the close of the current fiscal
- 28 year to the extent that obligations are carried forward. In
- 29 addition, reimbursements actually received to support the
- 30 obligations may also be carried forward.

- 1 Section 6104. Subgrants between Federal appropriations.
- 2 Subgrants may be made between Federal appropriations without
- 3 further approval of the General Assembly. The Secretary of the
- 4 Budget shall submit a list of subgrants to the chair and
- 5 minority chair of the Appropriations Committee of the Senate and
- 6 the chair and minority chair of the Appropriations Committee of
- 7 the House of Representatives quarterly. No subgrant to a State
- 8 agency, however, may be made from a restricted receipt account
- 9 without a specific appropriation by the General Assembly.
- 10 Section 6105. Utilization of emergency Federal funds.
- 11 (a) Natural disasters and civil disobedience. -- Federal funds
- 12 available for costs and damages resulting from natural disasters
- 13 or civil disobedience may be added to an appropriation contained
- 14 in this act or to funds otherwise appropriated or may be used
- 15 for the purposes prescribed by the Federal Government.
- 16 (b) Other emergencies. -- In addition to the money
- 17 appropriated by this act, money received from the Federal
- 18 Government for the purpose of disaster assistance or relief, or
- 19 other money received as a direct result of terrorist acts, money
- 20 for homeland security and defense and money for avian flu shall
- 21 be paid into the General Fund and are appropriated out of the
- 22 General Fund to the departments, boards, commissions or agencies
- 23 designated by the Governor.
- 24 (c) (Reserved).
- 25 (d) Federal funding related to COVID-19 and the impact of
- 26 COVID-19. -- The following apply to funds received from the
- 27 Federal Government for assistance with the response to the
- 28 COVID-19 pandemic and the economic impact of the COVID-19
- 29 pandemic:
- 30 (1) For Federal funds which are required by Federal law

- 1 to be allocated to a specific program which is in existence
- 2 prior to the effective date of this section, the Federal
- funds are hereby appropriated to the program.
- 4 (2) For Federal funds which are required by Federal law
- 5 to be allocated by the Commonwealth according to a formula
- 6 mandated by Federal law, the Federal funds are hereby
- 7 appropriated for allocation according to the formula.
- 8 (3) All other Federal funds under this subsection shall
- 9 be deposited in the COVID-19 Response Restricted Account and
- shall only be used upon appropriation by the General
- 11 Assembly.

- 15 Section 7101. Prior laws unaffected.
- 16 This act is not intended to be inconsistent with or to repeal
- 17 any provision of any act enacted at this or any prior session of
- 18 the General Assembly regulating the purchase of supplies, the
- 19 ordering of printing and binding, the purchase, maintenance and
- 20 use of motor vehicles, the method of making payments from the
- 21 State Treasury for any purpose or the functioning of any
- 22 administrative department, board or commission.
- 23 Section 7102. Compliance with other law before funds available.
- No appropriation made by this act to any department, board,
- 25 commission or agency of the Executive Department shall be
- 26 available unless and until the department, board, commission or
- 27 agency has complied with sections 615 and 616 of the act of
- 28 April 9, 1929 (P.L.177, No.175), known as The Administrative
- 29 Code of 1929.
- 30 Section 7103. Contracts prerequisite to encumbering or

- 1 committing funds.
- 2 Funds available to agencies, boards, departments, commissions
- 3 or other governmental entities under this act for the
- 4 procurement of supplies, services or construction shall not be
- 5 available for payment of or to be committed to or encumbered for
- 6 payment of the procurement unless and until the agency, board,
- 7 department or other governmental entity has complied with all of
- 8 the requirements applicable to the procurement that are
- 9 specified in 62 Pa.C.S. (relating to procurement) and in the
- 10 policies, procedures and regulations instituted in accordance
- 11 with 62 Pa.C.S.
- 12 Section 7104. Minority business set-asides.
- 13 (a) Duty to report. -- Each department or other
- 14 instrumentality of the Commonwealth listed in Subpart B of Part
- 15 II authorized to contract for buildings, highways, commodities,
- 16 equipment, supplies or services shall report to the General
- 17 Assembly all information pertinent to anticipated procurement
- 18 needs at the beginning of each quarter during a fiscal year.
- 19 (b) Definition.--As used in this section, the term "minority
- 20 business" means a minority business enterprise as defined in the
- 21 act of July 22, 1974 (P.L.598, No.206), known as the
- 22 Pennsylvania Minority Business Development Authority Act.
- 23 Section 7105. (Reserved).
- 24 Section 7106. Lapsing of unused funds.
- 25 (a) General rule. -- Except as otherwise provided by law or by
- 26 this section, that part of all appropriations in this act
- 27 unexpended, uncommitted or unencumbered as of the close of the
- 28 current fiscal year shall automatically lapse as of that day.
