8	This act shall be referred to as Cordelia's Law.
9	The General Assembly of the Commonwealth of Pennsylvania
10	hereby enacts as follows:
11	Section 1. Section 5511(a)(2.1) of Title 18 of the
12	Pennsylvania Consolidated Statutes is amended to read:
13	§ 5511. Cruelty to animals.
14	(a) Killing, maiming or poisoning domestic animals or zoo
15	animals, etc
16	* * *
17	(2.1) (i) A person commits a misdemeanor of the first
18	degree if he willfully and maliciously:
19	(A) Kills, maims, mutilates, tortures or
20	disfigures any dog [or], cat or equine animal,

whether belonging to himself or otherwise. [If a person kills, maims, mutilates, tortures or disfigures a dog quide for an individual who is blind, a hearing dog for an individual who is deaf or audibly impaired or a service dog for an individual who is physically limited, whether belonging to the individual or otherwise, that person, in addition to any other applicable penalty, shall be required to make reparations for veterinary costs in treating the dog and, if necessary, the cost of obtaining and training a replacement dog.]

- (B) Administers poison to or exposes any poisonous substance with the intent to administer such poison to any dog [or], cat or equine animal, whether belonging to himself or otherwise.
- (ii) Any person convicted of violating the provisions of this paragraph shall be sentenced to pay a fine of not less than \$1,000 or to imprisonment for not more than two years, or both. The court may also order a presentence mental evaluation. A subsequent conviction under this paragraph shall be a felony of the third degree. [This paragraph shall apply to dogs and cats only.]
- (iii) The killing of a dog [or], cat or equine

 animal by the owner of that animal is not malicious if it
 is accomplished in accordance with the act of December

 22, 1983 (P.L.303, No.83), referred to as the Animal
 Destruction Method Authorization Law.
- (iv) If a person kills, maims, mutilates, tortures or disfigures a guide dog for an individual who is blind,

26	(g) Development of guidelines. On or before December 31,
27	2017, the board shall develop guidelines to assist humane
28	society police officers, law enforcement officers, the courts
