AN ACT

- Amending the act of July 8, 1978 (P.L.752, No.140), entitled "An act providing for the forfeiture of the pensions of certain 2 public employees and authorizing the State or political 3 subdivision to garnish the pension benefits of certain public officers and employees upon conviction of certain criminal 5 activity related to their office or position of employment," extending the coverage of the act. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 10 Section 1. The definition of "crimes related to public office or public employment" in section 2 of the act of July 8, 11 1978 (P.L.752, No.140), known as the Public Employee Pension 12 13 Forfeiture Act, is amended to read: Section 2. Definitions.

- 15 The following words and phrases when used in this act shall
- 16 have, unless the context clearly indicates otherwise, the
- 17 meanings given to them in this section:
- 18 "Crimes related to public office or public employment." As_
- follows: 19
- (1) Any of the criminal offenses as set forth in the 20

- following provisions of Title 18 (Crimes and Offenses) of the
- 2 Pennsylvania Consolidated Statutes or other enumerated
- 3 statute when committed by a public official or public
- 4 employee through his public office or position or when his
- 5 public employment places him in a position to commit the
- 6 crime:
- 7 Any of the criminal offenses set forth in Subchapter B of
- 8 Chapter 31 (relating to definition of offenses) when the
- 9 criminal offense is committed by a school employee as defined
- in 24 Pa.C.S. § 8102 (relating to definitions) against a
- 11 student.
- 12 Section 3922 (relating to theft by deception) when the
- criminal culpability reaches the level of a misdemeanor of
- the first degree or higher.
- 15 Section 3923 (relating to theft by extortion) when the
- criminal culpability reaches the level of a misdemeanor of
- 17 the first degree or higher.
- 18 Section 3926 (relating to theft of services) when the
- criminal culpability reaches the level of a misdemeanor of
- the first degree or higher.
- 21 Section 3927 (relating to theft by failure to make
- required disposition of funds received) when the criminal
- culpability reaches the level of a misdemeanor of the first
- 24 degree or higher.
- 25 Section 4101 (relating to forgery).
- Section 4104 (relating to tampering with records or
- 27 identification).
- 28 Section 4113 (relating to misapplication of entrusted
- 29 property and property of government or financial
- 30 institutions) when the criminal culpability reaches the level

- of misdemeanor of the second degree.
- 2 Section 4701 (relating to bribery in official and
- 3 political matters).
- 4 Section 4702 (relating to threats and other improper
- 5 influence in official and political matters).
- 6 Section 4902 (relating to perjury).
- 7 Section 4903(a) (relating to false swearing).
- 8 Section 4904 (relating to unsworn falsification to
- 9 authorities).
- 10 Section 4906 (relating to false reports to law
- 11 enforcement authorities).
- 12 Section 4909 (relating to witness or informant taking
- 13 bribe).
- 14 Section 4910 (relating to tampering with or fabricating
- 15 physical evidence).
- Section 4911 (relating to tampering with public records
- or information).
- 18 Section 4952 (relating to intimidation of witnesses or
- 19 victims).
- 20 Section 4953 (relating to retaliation against witness,
- 21 victim or party).
- 22 Section 5101 (relating to obstructing administration of
- law or other governmental function).
- Section 5301 (relating to official oppression).
- 25 Section 5302 (relating to speculating or wagering on
- official action or information).
- 27 Article III of the act of March 4, 1971 (P.L.6, No.2),
- 28 known as the "Tax Reform Code of 1971."
- In addition to the foregoing specific crimes, the term
- 30 also includes all criminal offenses as set forth in Federal

- 1 law substantially the same as the crimes enumerated herein.
- 2 (2) Any offense that requires registration under 42
- 3 Pa.C.S. § 9799.15 (relating to period of registration) when
- 4 <u>committed by a public official or public employee.</u>

- 6 Section 2. This act shall take effect in 60 days.
