AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in miscellaneous provisions relating to accidents and accident reports, further providing for accident scene
- 4 clearance.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 3745.1(c) of Title 75 of the Pennsylvania
- 8 Consolidated Statutes is amended and the section is amended by
- 9 adding subsections to read:
- 10 § 3745.1. Accident scene clearance.
- 11 * * *
- 12 (c) Police officers.--A police officer may immediately
- 13 remove or direct removal of a wrecked vehicle at the owner's or <--
- 14 operator's expense if the owner or operator cannot remove the
- 15 wrecked vehicle or refuses or fails to have the vehicle removed
- 16 as required under this section. In carrying out the provisions
- 17 of this subsection, no liability shall attach to the police
- 18 officer, police department or, absent a showing of gross

- 1 negligence, to any person, Commonwealth agency, municipality or
- 2 <u>traffic incident professional</u> acting under the direction of the
- 3 police officer for damage to any vehicle or damage to or loss of
- 4 any portion of the contents of the vehicle.
- 5 (c.1) Traffic incident professional. -- Notwithstanding any
- 6 other provision of law, liability shall not attach to a
- 7 Commonwealth agency, commission, municipality or traffic
- 8 <u>incident professional</u>, absent a showing of gross negligence, for
- 9 damage to a vehicle, damage to a portion of the contents of the
- 10 vehicle, damage to property or personal injury as a result of a
- 11 traffic accident when performing an incident clearance function
- 12 <u>before the arrival of a police officer or at the direction of a</u>
- 13 police officer under subsection (c).
- 14 * * *
- (h) Definitions. -- As used in this section, the following
- 16 words and phrases shall have the meanings given to them in this
- 17 subsection unless the context clearly indicates otherwise:
- "Incident clearance function." An action by a traffic
- 19 incident professional that includes any of the following:
- 20 (1) Removal or the attempt to remove a vehicle or any
- 21 <u>portion of the contents of the vehicle from the roadway to</u>
- 22 the shoulder or other nearby place of safety.
- 23 (2) Incident detection and verification.
- 24 (3) Incident area security and protection.
- 25 (4) Rescue of persons from vehicles and hazardous
- environments.
- 27 (5) Emergency medical transportation and trained care.
- 28 (6) Hazardous materials response and containment.
- 29 (7) Fire suppression and elimination.
- 30 (8) Assistance to persons from a wrecked vehicle.

| 18 | LIMITED TO, A PERSON UNDER CONTRACT WITH A COMMONWEALTH AGENCY, |
| 19 | COMMISSION OR MUNICIPALITY. |
| 20 | Section 2. This act shall take effect in 60 days. |
