AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 2 and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and 6 imposing duties upon the Department of Revenue, certain 7 employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," in inheritance tax, further providing for the 10 rate of inheritance tax. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: Section 1. Section 2116(a)(1) of the act of March 4, 1971 14 15 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended 16 to read: Section 2116. Inheritance Tax. -- (a) (1) Inheritance tax 17 upon the transfer of property passing to or for the use of any 18 19 [of the following shall be at the rate of four and one-half per 20 cent: 21 grandfather, grandmother, father, mother, except (i)

transfers under subclause (1.2), and lineal descendants; or

- (ii) wife or widow and husband or widower of a child.]

- 6 (i) Four and one-half per cent for the estate of a decedent

- 9 <u>decedent dying on or after July 1, 2023, and before July 1,</u>
- 10 2024.
- 11 (iii) Four per cent for the estate of a decedent dying on or
- 12 after July 1, 2024, and before July 1, 2025.
- 13 <u>(iv) Three and three-quarters per cent for the estate of a</u>
- 14 <u>decedent dying on or after July 1, 2025, and before July 1,</u>
- 15 2026.
- 16 <u>(v) Three and one-quarter per cent for the estate of a</u>
- 17 <u>decedent dying on or after July 1, 2026, and before July 1, </u>
- 18 2027.
- 19 (vi) Two and three-quarters per cent for the estate of a
- 20 <u>decedent dying on or after July 1, 2027, and before July 1,</u>
- 21 2028.
- 22 <u>(vii) Two and one-quarter per cent for the estate of a</u>
- 23 decedent dying on or after July 1, 2028, and before July 1,
- 24 2029.
- 25 (viii) One and three-quarters per cent for the estate of a
- 26 decedent dying on or after July 1, 2029, and before July 1,
- 27 <u>2030.</u>
- 28 <u>(ix) One and one-quarter per cent for the estate of a</u>
- 29 <u>decedent dying on or after July 1, 2030, and before July 1,</u>
- 30 2031.

- 1 (x) Three quarters per cent for the estate of a decedent
- 2 dying on or after July 1, 2031, and before July 1, 2032.
- 3 (xi) Zero per cent for the estate of a decedent dying on or
- 4 <u>after July 1, 2032.</u>
