- 1 The General Assembly of the Commonwealth of Pennsylvania
- 2 hereby enacts as follows:
- 3 CHAPTER 1
- 4 PRELIMINARY PROVISIONS
- 5 Section 101. Short title.
- 6 This act shall be known and may be cited as the Adult
- 7 Education and Workforce Recovery Grant Program Act.
- 8 Section 102. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Adult education provider." An approved educational agency,
- 13 institution or organization making use of either professional or
- 14 voluntary personnel. The term includes:
- 15 (1) A school district.
- 16 (2) An intermediate unit.
- 17 (3) An area career and technical school.
- 18 (4) A community college.
- 19 (5) A literacy council.
- 20 (6) A local library.
- 21 (7) A community-based organization that is private, a
- 22 nonprofit organization and representative of communities or
- 23 significant parts of communities and provides adult or family
- 24 literacy education programs.
- 25 (8) An educational entity recognized by the Secretary of
- 26 Education for providing appropriate and effective adult basic
- or family literacy education programs.
- 28 (9) An education entity recognized by the Secretary of
- 29 Education for providing appropriate and effective education
- 30 exclusively to adult populations.

- 1 "Department." The Department of Education of the
 2 Commonwealth.
 3 "Eligible program participant." An individual who has
- 5 (1) is basic skills deficient;
- 6 (2) does not have a secondary school diploma or its

attained 18 years of age and satisfies one of the following:

- 7 recognized equivalent and has not achieved an equivalent-
- 8 level of education;

- 9 (3) is an English language learner; or
- 10 (4) requires additional training to reenter the
- 11 workforce after a job loss. AN INDIVIDUAL WHO:
- 12 (1) HAS ATTAINED 18 YEARS OF AGE AND SATISFIES ONE OF 13 THE FOLLOWING:
- 14 (I) IS BASIC SKILLS DEFICIENT;
- 15 (II) DOES NOT HAVE A SECONDARY SCHOOL DIPLOMA OR ITS

 16 RECOGNIZED EQUIVALENT AND HAS NOT ACHIEVED AN EQUIVALENT

 17 LEVEL OF EDUCATION;
- 18 (III) IS AN ENGLISH LANGUAGE LEARNER; OR
- 19 (IV) REQUIRES ADDITIONAL TRAINING TO REENTER THE
- 20 WORKFORCE AFTER A JOB LOSS OR GAP IN EMPLOYMENT; AND
- 21 (2) HAS BEEN ADVERSELY IMPACTED BY THE COVID-19 PUBLIC
- 22 HEALTH EMERGENCY.
- "Fund." The Adult Education and Workforce Recovery Grant
- 24 Program Fund established by this act.
- 25 "Grant." A grant issued by the department under this act.
- 26 "High school equivalency credential." The Commonwealth
- 27 Secondary School Diploma available to residents of this
- 28 Commonwealth who do not possess a high school diploma and have
- 29 met the criteria specified in 22 Pa. Code § 4.72 (relating to
- 30 credentials other than the high school diploma).

- 1 "Program." The Adult Education and Workforce Recovery Grant
- 2 Program established by this act.
- 3 CHAPTER 3
- 4 ADULT EDUCATION AND WORKFORCE RECOVERY
- 5 GRANT PROGRAM
- 6 Section 301. Establishment.
- 7 (a) General rule. -- The Adult Education and Workforce
- 8 Recovery Grant Program is established in the department. The
- 9 program shall provide grants as provided in this act.
- 10 (b) Fund. -- The Adult Education and Workforce Recovery Grant
- 11 Program Fund is established in the State Treasury.
- 12 (c) Source of fund.--
- 13 (1) The sum of \$15,000,000 in Federal money paid to the
- 14 Commonwealth under the American Rescue Plan Act of 2021
- 15 (Public Law 117-2, 135 Stat. 4) shall be transferred to the
- fund and, subject to payment of administrative costs as
- 17 provided in section 304, shall be allocated as follows:
- 18 (i) Eighty percent of the remaining money in the
- fund shall be used to provide grants to the entities
- described in paragraphs (1), (2), (3), (4), (5), (6), (7)
- and (8) of the definition of "adult education provider"
- in section 102.
- 23 (ii) Twenty percent of the remaining money in the
- fund shall be used to provide grants to entities
- described in paragraph (9) of the definition of "adult
- 26 education provider" in section 102 for programs that
- serve adult learners who hold a secondary diploma or its
- 28 recognized equivalent and need additional training to
- reenter the workforce.
- 30 (2) The department may reallocate between the grants

- specified in paragraph (1)(i) and (ii) any unspent funds
- 2 resulting from insufficient applicants following the initial
- 3 grant application period.
- 4 (d) Administration. -- The department shall make competitive
- 5 grants available to adult education providers for the following
- 6 purposes:
- 7 (1) Upskilling working-age adults for the post-COVID
- 8 workforce.
- 9 (2) Providing support to adult learners in completing a
- 10 high school equivalency credential.
- 11 (3) Providing technical training or job training
- 12 necessary to secure employment to participants coenrolled in
- adult basic education or transitioning directly from adult
- 14 basic education.
- 15 (4) Providing tuition assistance for grant participants
- 16 coenrolled in adult basic education or transitioning directly
- 17 from adult basic education.
- 18 (5) Providing digital literacy training.
- 19 (6) Providing career services, including career
- 20 exploration, planning and support identifying and evaluating
- 21 education and job training programs.
- 22 Section 302. Grants.
- 23 (a) Eligibility. -- An adult education provider shall be
- 24 eligible to apply for a grant under the program.
- 25 (b) Guidelines. -- The department shall develop guidelines
- 26 that specify the requirements for grants. The guidelines shall
- 27 include:
- 28 (1) The grant application process.
- 29 (2) Allowed and disallowed expenses.
- 30 (3) The method by which grantees will be evaluated on

- 1 performance to include outcome-based metrics.
- 2 (c) Awards.--
- 3 (1) The department may not award a grant in excess of \$500,000 to a qualified applicant.
- 5 (2) The department may award a grant for a multipartner 6 collaboration, in which case the dollar limit in paragraph
- 7 (1) shall not apply.
- 8 Section 303. Procedure for grant issuance.
- 9 (a) Application.--An eligible adult education provider may
- 10 submit an application to the department requesting a grant.
- 11 (b) Application requirements. -- A completed application must
- 12 describe the proposed grant activities in the form and manner
- 13 prescribed by the department. An application must include all of
- 14 the following:
- 15 (1) A description of the programming and services the
- adult education provider will offer in support of one or more
- of the purposes outlined in section 301(d).
- 18 (2) A description of the manner in which the adult
- 19 education provider will meet the guidelines under section
- 20 302 (b).
- 21 (3) A projection of costs associated with the proposed
- grant activities, including an enumeration of opportunities
- 23 to leverage other funding and programming resources.
- 24 (4) Information on occupations that will be the focus of
- 25 the program, including data on local demand.
- 26 (5) A description of strategies to recruit eligible
- 27 program participants.
- 28 (6) Information on industry-recognized credentials or
- 29 certifications awarded to program participants upon
- 30 completion of an education or job training.

- 1 (7) A start date for the proposed grant activities.
- 2 (8) A list of clear objectives and measurable goals that
- 3 the adult education provider will seek to achieve.
- 4 (9) AN ATTESTATION THAT GRANT MONEY WILL ONLY BE USED TO <--
- 5 PROVIDE PROGRAMMING AND SERVICES TO ELIGIBLE PROGRAM
- 6 PARTICIPANTS WHO HAVE BEEN ADVERSELY IMPACTED BY THE COVID-19
- 7 PUBLIC HEALTH EMERGENCY.
- 8 (c) Approval process. -- The department shall review and
- 9 approve grant applications that, in the sole discretion of the
- 10 department, satisfy the requirements of this act.
- 11 (d) Contractual relationship. -- Within 30 days of the
- 12 completion of the approval process, the department shall enter
- 13 into a contract with each adult education provider approved for
- 14 a grant. The contract shall require the signatories to provide
- 15 the services described in the approved application from money
- 16 appropriated or distributed for this purpose.
- 17 Section 304. Limit on administrative costs.
- No more than 5% of the money in the fund may be used by the
- 19 department for administrative costs.
- 20 CHAPTER 9
- 21 REPORTING
- 22 Section 901. Annual report.
- Not later than September 1 of each year AFTER GRANTS ARE
- 24 AWARDED, the department shall submit a report regarding the
- 25 implementation and outcomes of grants over the previous fiscal
- 26 year to the following:
- 27 (1) The Governor.
- 28 (2) The chairperson and minority chairperson of the
- 29 Appropriations Committee of the Senate.
- 30 (3) The chairperson and minority chairperson of the

- 1 Appropriations Committee of the House of Representatives.
- 2 (4) The chairperson and minority chairperson of the
- 3 Education Committee of the Senate.
- 4 (5) The chairperson and minority chairperson of the
- 5 Education Committee of the House of Representatives.
- 6 Section 902. Report contents.
- 7 In addition to information or analysis required by the
- 8 department, the annual report shall include information about
- 9 each grant awarded, including whether:

- 10 (1) The grant WHETHER THE GRANT RECIPIENTS achieved the <--
- 11 clear objectives and measurable goals proposed under section
- 12 303(b)(8).
- 13 (2) The number of eligible program participants.
- 14 (3) The amount expended.
- 15 CHAPTER 11
- 16 MISCELLANEOUS PROVISIONS
- 17 Section 1101. Effective date.
- 18 This act shall take effect immediately.
