AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in minors, further providing for
- 3 definitions.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6310.6 of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 6310.6. Definitions.
- 9 The following words and phrases when used in sections 6307
- 10 (relating to misrepresentation of age to secure liquor or malt
- 11 or brewed beverages) through 6310.3 (relating to carrying a
- 12 false identification card) shall have the meanings given to them
- 13 in this section unless the context clearly indicates otherwise:
- 14 "Furnish." To supply, give or provide to, or allow a minor
- 15 to possess on premises or property owned or controlled by the
- 16 person charged.
- 17 "Identification card." A driver's license, a Department of
- 18 Transportation nondriver's identification card or a card issued

- 1 by the Pennsylvania Liquor Control Board for the purpose of
- 2 identifying a person desiring liquor or malt or brewed
- 3 beverages, a card which falsely purports to be any of the
- 4 foregoing, or any card, paper or document which falsely
- 5 identifies the person by name, photograph, age or date of birth
- 6 as being 21 years of age or older.
- 7 "Liquor." Includes any alcoholic, spirituous, vinous,
- 8 fermented or other alcoholic beverage, powdered alcohol, or
- 9 combination of liquors and mixed liquor a part of which is
- 10 spirituous, vinous, fermented or otherwise alcoholic, including
- 11 all drinks or drinkable liquids, preparations or mixtures and
- 12 reused, recovered or redistilled denatured alcohol usable or
- 13 taxable for beverage purposes which contain more than 0.50% of
- 14 alcohol by volume, except pure ethyl alcohol and malt or brewed
- 15 beverages.
- 16 "Malt or brewed beverages." Any beer, lager beer, ale,
- 17 porter or similar fermented malt beverage containing 0.50% or
- 18 more of alcohol by volume, by whatever name such beverage may be
- 19 called.
- 20 "Powdered alcohol." Alcohol sold in powdered or molecularly
- 21 encapsulated form for either direct use or reconstitution.
- 22 Section 2. This act shall take effect in 60 days.
