AN ACT

1 Authorizing the Department of General Services, with the

2 approval of the Department of Military and Veterans Affairs

and the Governor, to grant and convey to Monroe County

4 Municipal Waste Management Authority, or its successors or

assigns, certain lands, buildings and improvements situate in

6 Stroud Township, Monroe County.

- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Conveyance in Stroud Township, Monroe County.
- 10 (a) Authorization for conveyance. -- The Department of General
- 11 Services, with the approval of the Department of Military and
- 12 Veterans Affairs and the Governor, is authorized on behalf of
- 13 the Commonwealth of Pennsylvania to grant and convey to Monroe
- 14 County Municipal Waste Management Authority, or its successors
- 15 or assigns, the tract of land described under subsection (b)
- 16 together with any buildings, structures or improvements thereon,
- 17 situate in Stroud Township, Monroe County, for \$45,000 and under
- 18 terms and conditions to be established in a Lease with the
- 19 Option to Purchase Agreement with the Department of General
- 20 Services.

- 1 (b) Property description. -- The property to be conveyed under
- 2 subsection (a) consists of approximately 10.01 acres of land and
- 3 ancillary buildings located thereon, bounded and more
- 4 particularly described as follows:
- 5 ALL THAT CERTAIN tract, parcel or piece of land situate in
- 6 the Township of Stroud, County of Monroe and State of
- 7 Pennsylvania, bounded and described as wit:
- 8 BEGINNING at a point near the middle of the state road
- 9 leading from Shafers School House to N/F Wigwam Park; thence
- 10 along the northeasterly side of a township road (bearing from
- 11 the M.M. of 1961) South 85 degrees 20 minutes West (at 62.79
- 12 feet passing an iron pipe) 1089.67 feet to an iron pipe; thence
- 13 by other lands of N/F Marion C. Brislin, of which this tract was
- 14 formerly a part, North 29 degrees 43 minutes 5 seconds West 345
- 15 feet to an iron pipe; thence by the same, North 82 degrees 9
- 16 minutes 15 seconds East (at 1347.74 feet passing an arc pipe)
- 17 1371.73 feet to a point near the middle of said state road;
- 18 thence averaging the middle of said state road, South 4 degrees
- 19 31 minutes West 196.80 feet to a point; thence by the same,
- 20 South 23 degrees 7 minutes 40 seconds West 219.69 feet to the
- 21 place of Beginning.
- 22 Containing 10.01 acres, more or less.
- 23 BEING Parcel ID No: 17638000962284.
- 24 BEING the same premises conveyed from Marion C. Brislin,
- 25 widow, to the Commonwealth of Pennsylvania, by deed dated
- 26 December 12, 1962, recorded in the Monroe County Recorder of
- 27 Deeds Office in Deed Book 308, Page 996.
- 28 (c) Easements. -- The conveyance shall be made under and
- 29 subject to all lawful and enforceable easements, servitudes and
- 30 rights of others including, but not confined to, streets,

- 1 roadways and rights of telephone, telegraph, water, electric,
- 2 gas or pipeline companies, as well as under and subject to
- 3 lawful and enforceable estates or tenancies vested in third
- 4 persons appearing of record, for any portion of the land or
- 5 improvements erected thereon.
- 6 (d) Condition. -- The conveyance shall be made under and
- 7 subject to the condition, which shall be contained in the deed
- 8 of conveyance, that no portion of the property conveyed may be
- 9 used as a licensed facility, as defined in 4 Pa.C.S. § 1103
- 10 (relating to definitions), or any other similar type of facility
- 11 authorized under State law. The condition shall be a covenant
- 12 running with the land and shall be binding upon the grantee, its
- 13 successors and assigns. Should the grantee, its successors or
- 14 assigns permit any portion of the property authorized to be
- 15 conveyed in this section to be used in violation of this
- 16 subsection, the title shall immediately revert to and revest in
- 17 the grantor.
- 18 (e) Deed.--The deed of conveyance shall be by Special
- 19 Warranty Deed and shall be executed by the Secretary of General
- 20 Services in the name of the Commonwealth of Pennsylvania.
- 21 (f) Costs and fees.--Costs and fees incidental to the
- 22 conveyance shall be borne by the grantee.
- 23 (g) Proceeds of sale. -- The proceeds from the sale shall be
- 24 deposited in the State Treasury Armory Fund.
- 25 (h) Alternative disposition. -- In the event that the
- 26 conveyance is not executed per the terms and conditions as
- 27 established in the Lease with the Option to Purchase Agreement
- 28 with the Department of General Services, the property may be
- 29 disposed of by competitive bid.
- 30 Section 2. This act shall take effect immediately.
