AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the
- laws relating thereto," in terms and courses of study, further providing for firefighter and emergency service
- 7 training and establishing the Fire Training Fund.

- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 1550 of the act of March 10, 1949
- 11 (P.L.30, No.14), known as the Public School Code of 1949, is
- 12 amended to read:
- 13 Section 1550. Firefighter and Emergency Service Training. --
- 14 (a) [Beginning with the 2003-2004 school year and each school
- 15 year thereafter, a] \underline{A} school district may offer firefighter and
- 16 emergency service training as credit-earning courses to students
- 17 of the age of sixteen (16) years or older, except as otherwise
- 18 provided in subsection (c). Such courses may include:
- 19 (1) Training as a Firefighter I from the National Board on
- 20 Fire Service Professional Qualifications.

- 1 (2) Training as an emergency medical technician pursuant to
- 2 the act of July 3, 1985 (P.L.164, No.45), known as the
- 3 "Emergency Medical Services Act."
- 4 (b) A school district that offers firefighter and emergency
- 5 service training as credit-earning courses shall provide
- 6 transportation to and supervision during any firefighter and
- 7 emergency service training program that takes place off school
- 8 grounds. Supervision of training shall be conducted as a
- 9 cooperative education program in accordance with the provisions
- 10 of 22 Pa. Code § 11.28 (relating to out-of-school programs).
- 11 (c) The Secondary Education Fire Training Pilot Program is
- 12 <u>established</u>. The purpose of the pilot program is to provide high
- 13 <u>school students with instruction through a partnership between</u>
- 14 <u>institutions of higher education and school districts or area</u>
- 15 career and technical schools, or both, to increase the number of
- 16 individuals capable of becoming volunteer firefighters. The
- 17 pilot program shall be implemented in accordance with the
- 18 <u>following:</u>
- 19 (1) The State Fire Commissioner shall accept proposals from
- 20 <u>institutions of higher education in this Commonwealth for the</u>
- 21 pilot program. From the proposals submitted, the State Fire
- 22 Commissioner shall select three institutions of higher education
- 23 to offer the pilot program. The State Fire Commissioner, to the
- 24 greatest extent practicable, shall select one institution of
- 25 higher education each from the eastern, central and western
- 26 regions of this Commonwealth. Nothing in this section shall
- 27 prohibit an institution of higher education from incorporating
- 28 emergency medical services instruction in the pilot program.
- 29 (2) An institution of higher education selected by the State
- 30 Fire Commissioner shall operate the pilot program by entering

- 1 into an agreement with a school district or an area career and
- 2 technical school, or both, for the provision of fire instruction
- 3 to students who are in at least the ninth grade and leading to
- 4 <u>Firefighter I certification.</u>
- 5 (3) A nonlapsing, restricted account is established in the
- 6 State Treasury, to be known as the Fire Training Fund. The State
- 7 Fire Commissioner may accept monetary donations and other money
- 8 for deposit into the Fire Training Fund from a person, business,
- 9 foundation, tax-exempt organization under section 501(c)(3) of
- 10 the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C.
- 11 § 501(c)(3)) or government entity on behalf of the Commonwealth.
- 12 (4) Money may be appropriated to the State Fire Commissioner
- 13 to carry out the provisions of this subsection. Each institution
- 14 of higher education offering the pilot program shall receive at
- 15 least one hundred fifty thousand dollars (\$150,000) for the
- 16 duration of the pilot program.
- 17 (5) Any funds appropriated, donated or transferred under
- 18 this subsection and interest earned on the Fire Training Fund
- 19 shall be deposited into the Fire Training Fund.
- 20 (6) During the pilot program, the Legislative Budget and
- 21 Finance Committee shall conduct a survey of volunteer fire
- 22 companies in the municipalities surrounding the school districts
- 23 and area career and technical schools that participate in the
- 24 pilot program to determine whether the pilot program is
- 25 <u>increasing the number of volunteer firefighters and any</u>
- 26 additional recommendations. The results of the survey shall be
- 27 <u>submitted to the chair and minority chair of the Veterans</u>
- 28 Affairs and Emergency Preparedness Committee of the Senate and
- 29 the chair and minority chair of the Veterans Affairs and
- 30 Emergency Preparedness Committee of the House of Representatives

- 1 within six (6) months of the expiration of the pilot program.
- 2 (7) The pilot program shall expire four (4) years from the
- 3 effective date of this subsection.
- 4 (d) As used in this section, the term "institution of higher
- 5 <u>education" means a community college operating under Article</u>
- 6 XIX-A, a college operating under Article XIX-G or a university
- 7 <u>within the State System of Higher Education.</u>
- 8 Section 2. This act shall take effect January 1, 2021, or
- 9 immediately, whichever is later.
