## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, further providing for firefighter and emergency service 5 training and establishing the Fire Training Fund. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. Section 1550 of the act of March 10, 1949 10 11 (P.L.30, No.14), known as the Public School Code of 1949, is 12 amended to read: 13 Section 1550. Firefighter and Emergency Service Training .--14 [Beginning with the 2003-2004 school year and each school 15 year thereafter, a] A school district may offer firefighter and 16 emergency service training as credit-earning courses to students 17 of the age of sixteen (16) years or older, except as otherwise 18 provided in subsection (c). Such courses may include:
- 19 (1) Training as a Firefighter I from the National Board on
- 20 Fire Service Professional Qualifications.

- 1 (2) Training as an emergency medical technician pursuant to
- 2 the act of July 3, 1985 (P.L.164, No.45), known as the
- 3 "Emergency Medical Services Act."
- 4 (b) A school district that offers firefighter and emergency
- 5 service training as credit-earning courses shall provide
- 6 transportation to and supervision during any firefighter and
- 7 emergency service training program that takes place off school
- 8 grounds. Supervision of training shall be conducted as a
- 9 cooperative education program in accordance with the provisions
- 10 of 22 Pa. Code § 11.28 (relating to out-of-school programs).
- 11 (c) The Secondary Education Fire Training Pilot Program is
- 12 <u>established</u>. The purpose of the pilot program is to provide high
- 13 <u>school students with instruction through a partnership between</u>
- 14 <u>institutions of higher education and school districts or area</u>
- 15 career and technical schools, or both, to increase the number of
- 16 <u>individuals capable of becoming volunteer firefighters. The</u>
- 17 pilot program shall be implemented in accordance with SECTION 7 <--
- 18 OF THE ACT OF OCTOBER 24, 2012 (P.L.1209, NO.151), KNOWN AS THE
- 19 CHILD LABOR ACT, AND the following:
- 20 (1) The State Fire Commissioner shall accept proposals from
- 21 institutions of higher education in this Commonwealth for the
- 22 pilot program. From the proposals submitted, the State Fire
- 23 Commissioner shall select three institutions of higher education
- 24 to offer the pilot program. The State Fire Commissioner, to the
- 25 greatest extent practicable, shall select one institution of
- 26 higher education each from the eastern, central and western
- 27 regions of this Commonwealth. Nothing in this section shall
- 28 prohibit an institution of higher education from incorporating
- 29 <u>emergency medical services instruction in the pilot program.</u>
- 30 (2) An institution of higher education selected by the State

- 1 Fire Commissioner shall operate the pilot program by entering
- 2 into an agreement with a school district or an area career and
- 3 technical school, or both, for the provision of fire instruction
- 4 to students who are in at least the ninth grade and leading to
- 5 Firefighter I certification.
- 6 (3) A nonlapsing, restricted account is established in the
- 7 State Treasury, to be known as the Fire Training Fund. The State
- 8 Fire Commissioner may accept monetary donations and other money
- 9 for deposit into the Fire Training Fund from a person, business,
- 10 foundation, tax-exempt organization under section 501(c)(3) of
- 11 the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C.
- 12 § 501(c)(3)) or government entity on behalf of the Commonwealth.
- 13 (4) Money may be appropriated to the State Fire Commissioner
- 14 to carry out the provisions of this subsection. Each institution
- 15 of higher education offering the pilot program shall receive at
- 16 least one hundred fifty thousand dollars (\$150,000) for the
- 17 duration of the pilot program.
- 18 <u>(5) Any funds appropriated, donated or transferred under</u>
- 19 this subsection and interest earned on the Fire Training Fund
- 20 shall be deposited into the Fire Training Fund.
- 21 (6) During the pilot program, the Legislative Budget and
- 22 Finance Committee shall conduct a survey of volunteer fire
- 23 companies in the municipalities surrounding the school districts
- 24 and area career and technical schools that participate in the
- 25 pilot program to determine whether the pilot program is
- 26 increasing the number of volunteer firefighters and any
- 27 <u>additional recommendations. The results of the survey shall be</u>
- 28 submitted to the chair and minority chair of the Veterans
- 29 Affairs and Emergency Preparedness Committee of the Senate and
- 30 the chair and minority chair of the Veterans Affairs and

- 1 <u>Emergency Preparedness Committee of the House of Representatives</u>
- 2 within six (6) months of the expiration of the pilot program.
- 3 (7) The pilot program shall expire four (4) years from the
- 4 effective date of this subsection.
- 5 (d) As used in this section, the term "institution of higher
- 6 <u>education</u>" means a community college operating under Article
- 7 XIX-A, a college operating under Article XIX-G or a university
- 8 within the State System of Higher Education.
- 9 Section 2. This act shall take effect January 1, 2021 2022, <--
- 10 or immediately, whichever is later.
