## AN ACT

1 2 3 4 5 6	Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, providing for face covering or mask mandate opt out.
7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. The act of March 10, 1949 (P.L.30, No.14), known
10	as the Public School Code of 1949, is amended by adding a
11	section to read:
12	Section 1419.1. Face Covering or Mask Mandate Opt Out(a)
13	<u>A parent or legal guardian of a child of school age may opt out</u>
14	the child from wearing a face covering or mask, which the
15	child's school imposes as a result of a recommendation or
16	mandate from the Secretary of Health or a local board or
17	department of health, that is primarily responsible for the
18	prevention and control of communicable and non-communicable
19	disease, including disease control in public and private schools
20	as set forth under section 3 of the act of April 23, 1956 (1955

1	P.L.1510, No.500), known as the Disease Prevention and Control
2	Law of 1955.
3	(b) The child's school shall be required to develop and
4	post, on the school's publicly accessible Internet website, a
5	form to allow for a parent or legal guardian of the child to opt
6	out the child from wearing a face covering or mask. The form may
7	not require the parent or legal guardian to provide an excuse
8	for the opt out.
9	(c) The form shall also state that a child of school age
10	whose parent or legal guardian has opted out the child from
11	wearing a face covering or mask shall not be subject to any
12	harassment or discriminatory treatment, including being:
13	(1) Relegated to certain physical locations.
14	(2) Isolated during school activities.
15	(3) Excluded from any school-sponsored events or activities.
16	(d) As used in this section
17	"Face covering or mask" means material covering the nose and
18	mouth that is secured to the head with ties, straps or loops
19	over the ears or is wrapped around the lower face. The face
20	covering can be made of a variety of synthetic or natural
21	fabrics, including cotton, silk or linen. The face covering may
22	be factory-made, sewn by hand or be improvised from household
23	items, including scarfs, bandanas, t-shirts, sweatshirts or
24	towels.
25	"Local board or department of health" means the term as
26	defined under section 2(f) of the act of April 23, 1956 (1955
27	P.L.1510, No.500), known as the Disease Prevention and Control
28	Law of 1955.
29	Section 2. This act shall take effect immediately.
