AN ACT

Amending the act of April 27, 1905 (P.L.312, No.218), entitled "An act creating a Department of Health, and defining its 2 powers and duties," further providing for the administrative 3 structure of the Department of Health, establishing the office of Chief Nursing Officer of the Commonwealth and 5 providing for the powers and duties of the Chief Nursing 6 Officer of the Commonwealth. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1 of the act of April 27, 1905 (P.L.312, 11 No.218), entitled "An act creating a Department of Health, and defining its powers and duties," is amended to read: 12 13 Section 1. Be it enacted, &c., (a) The Department of Health 14 shall consist of a Secretary of Health, an advisory board [and], a Physician General[. 15 16 (b) The secretary shall be the head of the department, and 17 shall be appointed by the Governor, with the advice and consent of the Senate. The secretary shall be either a graduate of an 18 19 accredited medical or osteopathic medical school who is a practicing physician licensed by the Commonwealth or an 20

- 1 individual with professional experience in the field of public
- 2 health, health services delivery or education or training of
- 3 health service professionals. The secretary shall serve at the
- 4 pleasure of the Governor.
- 5 (c) There shall be an office of Physician General within the
- 6 administrative structure of the department. The Physician
- 7 General shall be appointed by the Governor by and with the
- 8 advice and consent of the Senate. The department shall provide
- 9 adequate staff and other support as needed. The Physician
- 10 General shall be a graduate of an accredited medical or
- 11 osteopathic medical school and shall be a practicing physician
- 12 licensed by the Commonwealth. The Physician General shall serve
- 13 at the pleasure of the Governor. The Physician General shall:
- (1) Advise the Governor and the secretary on health policy.
- 15 (2) Participate in the decision-making process of the
- 16 department on policies relating to all medical and public
- 17 health-related issues and in the decision-making process of
- 18 other executive branch agencies as directed by the Governor.
- 19 (3) Review professional standards and practices in medicine
- 20 and public health which are related to matters within the
- 21 jurisdiction of the department and other executive branch
- 22 agencies.
- 23 (4) Consult with recognized experts on medical and public
- 24 health matters which are within the jurisdiction of the
- 25 department and other executive branch agencies.
- 26 (5) Provide advice on medical and public health issues to
- 27 the secretary and to other executive branch agencies.
- 28 (6) Coordinate educational, informational and other programs
- 29 for the promotion of wellness, public health and related medical
- 30 issues in this Commonwealth and serve as the primary advocate

- 1 for these programs.
- 2 (7) Consult with experts in this Commonwealth and other
- 3 states regarding medical research, innovation and development
- 4 which relate to programs and issues of importance to the
- 5 department and the Commonwealth.
- 6 (8) Perform such other duties as directed by the Governor.
- 7 (9) When the secretary is not a physician, serve as a voting
- 8 member of the State Board of Medicine and the State Board of
- 9 Osteopathic Medicine. The Physician General may provide a
- 10 designee to serve in his or her stead. The salary and other
- 11 conditions of employment shall be set by the Executive Board.]
- 12 <u>and a Chief Nursing Officer of the Commonwealth.</u>
- 13 (b) The following apply to the Secretary of Health:
- 14 (1) The secretary shall be the head of the department and
- 15 shall be appointed by the Governor, with the advice and consent
- 16 of the Senate.
- 17 (2) The secretary shall be:
- 18 (i) a graduate of an accredited medical or osteopathic
- 19 medical school and a practicing physician licensed by the
- 20 Commonwealth; or
- 21 (ii) an individual with professional experience in the field
- 22 of public health, health services delivery or education or
- 23 training of health service professionals.
- 24 (3) The secretary shall serve at the pleasure of the
- 25 Governor.
- 26 (c) The following apply to the Physician General:
- 27 (1) There shall be an office of Physician General within the
- 28 administrative structure of the department.
- 29 (2) The Physician General shall be appointed by the
- 30 Governor, with the advice and consent of the Senate.

- 1 (3) The department shall provide adequate staff and other
- 2 <u>support as needed for the Physician General.</u>
- 3 (4) The Physician General shall be:
- 4 (i) a graduate of an accredited medical or osteopathic
- 5 medical school; and
- 6 (ii) a practicing physician licensed by the Commonwealth.
- 7 (5) The Physician General shall serve at the pleasure of the
- 8 <u>Governor</u>.
- 9 <u>(6) The Physician General shall:</u>
- 10 (i) Advise the Governor and the secretary on health policy.
- 11 (ii) Participate in the decision-making process of the
- 12 <u>department on policies relating to all medical and public</u>
- 13 <u>health-related issues and in the decision-making process of</u>
- 14 other executive branch agencies as directed by the Governor.
- 15 (iii) Review professional standards and practices in
- 16 medicine and public health which are related to matters within
- 17 the jurisdiction of the department and other executive branch
- 18 <u>agencies</u>.
- 19 (iv) Consult with recognized experts on medical and public
- 20 health matters which are within the jurisdiction of the
- 21 <u>department and other executive branch agencies.</u>
- 22 (v) Provide advice on medical and public health issues to
- 23 the secretary and to other executive branch agencies.
- 24 (vi) Coordinate educational, informational and other
- 25 programs for the promotion of wellness, public health and
- 26 related medical issues in this Commonwealth and serve as the
- 27 primary advocate for these programs.
- 28 (vii) Consult with experts in this Commonwealth and other
- 29 states regarding medical research, innovation and development
- 30 which relate to programs and issues of importance to the

- 1 <u>department and the Commonwealth.</u>
- 2 <u>(viii) Perform other duties as directed by the Governor.</u>
- 3 <u>(ix) When the secretary is not a physician, serve as a</u>
- 4 voting member of the State Board of Medicine and the State Board
- 5 of Osteopathic Medicine.
- 6 (7) The Physician General may provide a designee to serve in
- 7 <u>the Physician General's stead.</u>
- 8 (8) The salary and other conditions of employment for the
- 9 Physician General shall be set by the Executive Board.
- 10 (c.1) The following apply to the Chief Nursing Officer of
- 11 the Commonwealth:
- 12 (1) There shall be an office of Chief Nursing Officer of the
- 13 <u>Commonwealth within the administrative structure of the</u>
- 14 <u>department</u>.
- 15 (2) The Chief Nursing Officer of the Commonwealth shall be
- 16 appointed by the Governor with the advice and consent of the
- 17 Senate.
- 18 (3) The department shall provide adequate staff and other
- 19 <u>support as needed for the Chief Nursing Officer of the</u>
- 20 Commonwealth.
- 21 (4) The Chief Nursing Officer of the Commonwealth shall be:
- 22 (i) a graduate of an accredited school of nursing;
- 23 (ii) a practicing nurse licensed by the Commonwealth; and
- 24 (iii) a registered nurse with an unencumbered license issued
- 25 by the Commonwealth who has at least ten years of working
- 26 experience as a registered nurse, INCLUDING AT LEAST FIVE YEARS <--
- 27 PROVIDING DIRECT CARE TO PATIENTS, and who has an advanced
- 28 <u>degree in nursing or public health.</u>
- 29 (5) The Chief Nursing Officer of the Commonwealth shall
- 30 serve at the pleasure of the Governor.

- 1 (6) The Chief Nursing Officer of the Commonwealth shall:
- 2 (i) Advise the Governor and the secretary on health policy.
- 3 (ii) Participate in the decision-making process of the
- 4 <u>department on policies relating to all nursing and public</u>
- 5 health-related issues and in the decision-making process of
- 6 other executive branch agencies as directed by the Governor.
- 7 (iii) Review professional standards and practices in nursing
- 8 and public health which are related to matters within the
- 9 jurisdiction of the department and other executive branch
- 10 agencies.
- 11 (iv) Consult with recognized experts on nursing and public
- 12 <u>health matters which are within the jurisdiction of the</u>
- 13 <u>department and other executive branch agencies.</u>
- 14 (v) Provide advice on nursing and public health issues to
- 15 the secretary and to other executive branch agencies.
- 16 <u>(vi) Coordinate educational, informational and other</u>
- 17 programs for the promotion of wellness, public health and
- 18 related nursing issues in this Commonwealth and serve as the
- 19 primary advocate for these programs.
- 20 (vii) Consult with experts in this Commonwealth and other
- 21 states regarding health care research, innovation and
- 22 development which relate to programs and issues of importance to
- 23 <u>the department and the Commonwealth.</u>
- 24 (viii) Perform other duties as directed by the Governor.
- 25 (ix) Serve as a voting member of the State Board of Nursing.
- 26 The following apply:
- 27 (A) The Chief Nursing Officer of the Commonwealth shall
- 28 serve as one of the six registered nurses appointed by the
- 29 Governor to serve on the State Board of Nursing. The majority of
- 30 the members elected to the Senate shall not advise and consent

- 1 to the Chief Nursing Officer of the Commonwealth serving on the
- 2 State Board of Nursing.
- 3 (B) The Chief Nursing Officer of the Commonwealth may
- 4 appoint a designee to serve on the State Board of Nursing. If
- 5 the Chief Nursing Officer of the Commonwealth appoints a
- 6 designee, the designee shall be a registered nurse and shall
- 7 only serve as the designee with the advice and consent of the
- 8 <u>majority of the members elected to the Senate.</u>
- 9 (C) Upon the first vacancy on the State Board of Nursing
- 10 after the effective date of this clause, through the death,
- 11 resignation, disqualification or term expiration of a member of
- 12 the State Board of Nursing, the Chief Nursing Officer of the
- 13 Commonwealth, or the designee of the Chief Nursing Officer of
- 14 the Commonwealth in accordance with clause (B), shall become a
- 15 member of the State Board of Nursing. The position of Chief
- 16 Nursing Officer of the Commonwealth, or the designee of the
- 17 Chief Nursing Officer of the Commonwealth, shall become a
- 18 permanent designated member of the State Board of Nursing.
- 19 (7) Funds from the Professional Licensure Augmentation
- 20 Account shall be provided to the department for use in the
- 21 performance of the duties of the office of Chief Nursing Officer
- 22 of the Commonwealth.
- 23 (8) Nothing in this subsection shall permit the Chief
- 24 Nursing Officer of the Commonwealth to act independently of the
- 25 <u>secretary.</u>
- 26 (d) The department shall have an official seal.
- 27 Section 2. This act shall take effect in 60 days.
