AN ACT

- 1 Authorizing the Department of Transportation, with the approval
- of the Governor, to grant and convey to Center Square
- 3 Commons, L.P., certain lands situate in the Township of
- Whitpain, Montgomery County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Conveyance in Township of Whitpain, Montgomery
- 8 County.
- 9 (a) Authorization. -- The Department of Transportation, with
- 10 the approval of the Governor, is hereby authorized on behalf of
- 11 the Commonwealth of Pennsylvania to enter into a land transfer
- 12 with Center Square Commons, L.P. on certain land situated in the
- 13 Township of Whitpain, Montgomery County, as described in
- 14 subsection (b) for fair market value based on an appraisal and
- 15 under terms and conditions to be established in an Agreement of
- 16 Sale.
- 17 (b) Property description. -- The property to be conveyed to
- 18 Center Square Commons, L.P. contains a calculated area of 52,496
- 19 square feet or 1.205 acres of land, more or less that is subject

- 1 to easements and restrictions of record, if any, and begins at a
- 2 point in the southeasterly Right of Way line of DeKalb Pike
- 3 (a.k.a. S.R. 202), (R.O.W. varies) where the same is intersected
- 4 by the line dividing Unit 34 and Unit 4 (n/f Village of Center
- 5 Square, LLC) Block 4 and running; thence: 1) S 53° 31' 54" E,
- 6 along the said dividing line a distance of 369.45 feet to a
- 7 point, 2) S 38° 19' 40" W, along the same a distance of 235.03
- 8 feet to a point, 3) N 53° 37' W, along the line dividing Unit
- 9 34, Block 5 and Unit 4 (n/f Leoni Family-New Hanover Square
- 10 Limited Partnership) then Unit 1, (n/f Leoni Family-New Hanover
- 11 Square Limited Partnership) Block 4, a distance of 197.01 feet
- 12 to a point, 4) N 35° 42' 44" E, along the line dividing Units 34
- 13 and 1, (n/f Robbin L. Cramer DMD and Robert Cramer) then Unit 2
- 14 (n/f Richard E. and Margie B. Strawhacker), a distance of 138.48
- 15 feet to a point, 5) N 37° 56' 20" E, along the line dividing
- 16 Units 34 and 3 (n/f Center Square 938 DeKalb, LP) Block 5, a
- 17 distance of 65.68 feet, 6) N 53° 13' 06" W, along the line
- 18 dividing Units 34 and 3, Block 5, a distance of 167.67 feet to a
- 19 point, and 7) Along the southeasterly Right of Way line of
- 20 DeKalb Pike along a curve to the right, having a radius of
- 21 1,900.00 feet, (central angle 0° 54' 53"), an arc length of 30.33
- 22 feet, a chord bearing N 42° 07' 26" E, a distance of 30.33 feet
- 23 to the point and place of beginning.
- 24 (c) Conditions. -- The conveyance shall be made under and
- 25 subject to all lawful and enforceable easements, servitudes and
- 26 rights of others, including, but not confined to, streets and
- 27 roadways, and rights of any telephone, telegraph, water,
- 28 electric, gas or pipeline companies, as well as under and
- 29 subject to any lawful and enforceable estates or tenancies
- 30 vested in third persons appearing of record, for any portion of

- 1 the land or improvements erected thereon.
- 2 (d) Restriction. -- The conveyance shall be made under and
- 3 subject to the condition, which shall be contained in the deed
- 4 of conveyance, that no portion of the property conveyed shall be
- 5 used as a licensed facility, as defined in 4 Pa.C.S. § 1103
- 6 (relating to definitions), or any other similar type of facility
- 7 authorized under the laws of this Commonwealth. The condition
- 8 shall be a covenant running with the land and shall be binding
- 9 upon the grantee, its successors and assigns. Should the
- 10 grantee, its successors or assigns, permit any portion of the
- 11 property authorized to be conveyed in this section to be used in
- 12 violation of this subsection, the title shall immediately revert
- 13 to and revest in the grantor.
- 14 (e) Deed of conveyance. -- The deed of conveyance shall be by
- 15 quit claim deed and shall be executed by the Secretary of
- 16 Transportation in the name of the Commonwealth of Pennsylvania.
- 17 (f) Costs and fees. -- Costs and fees incidental to this
- 18 conveyance shall be borne by the grantee.
- 19 (g) Deposit of proceeds. -- Proceeds from the sale shall be
- 20 deposited into the Motor License Fund.
- 21 Section 2. Effective date.
- This act shall take effect immediately.
