9	Section 1. The act of March 10, 1949 (P.L.30, No.14), known

15	Section 1501-N. Definitions.
16	The following words and phrases when used in this article
17	shall have the meanings given to them in this section unless the
18	<pre>context clearly indicates otherwise:</pre>
19	"Department." The Department of Education of the
20	Commonwealth.

- 1 "Program." The School District Shared Services Incentive
- 2 Grant Program established under section 1502-N.
- 3 Section 1502-N. Establishment and purpose.
- 4 The School District Shared Services Incentive Grant Program
- 5 <u>is established and shall be administered by the department.</u>
- 6 Grants provided under the program shall be used to improve and
- 7 enhance the capabilities of school districts through shared
- 8 <u>services activities between partners that may include other</u>
- 9 school districts, other schools, universities and colleges,
- 10 businesses, municipalities, nonprofits and community health
- 11 centers to provide agreements for services such as pupil
- 12 transportation, purchasing, administration, safety and security,
- 13 <u>health services or food services and nutrition.</u>
- 14 Section 1503-N. Notice.
- By March 1, 2024, and each March 1 thereafter, the department
- 16 shall provide information regarding the availability and award
- 17 of program grant money on the publicly accessible Internet
- 18 website of the department and transmit notice to the Legislative
- 19 Reference Bureau for publication in the next available issue of
- 20 the Pennsylvania Bulletin.
- 21 Section 1504-N. Appropriation.
- 22 The General Assembly shall appropriate money as it deems
- 23 <u>necessary to pay the costs for the implementation and</u>
- 24 administration of this article.
- 25 <u>Section 1505-N. Report.</u>
- 26 By March 1, 2024, and each March 1 thereafter, the department
- 27 shall prepare and submit a report to the General Assembly on the
- 28 amount, purpose and recipients of program grant money awarded in
- 29 the prior calendar year under this article.
- 30 Section 1506-N. Regulations.

- 1 The department shall promulgate regulations as it deems
- 2 <u>necessary to administer and award grants under this article.</u>
- 3 Section 2. This act shall take effect in one year.
