Amending Titles 18 (Crimes and Offenses) and 51 (Military 1 2 Affairs) of the Pennsylvania Consolidated Statutes, in proprietary and official rights, further providing for the 3 4 offense of wearing of uniforms and insignia and 5 misrepresentation of military service or honors; and, in 6 State Veterans' Commission and Deputy Adjutant General for 7 Veterans' Affairs, further providing for Veterans' Trust 8 Fund. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 6701 of Title 18 of the Pennsylvania 12 Consolidated Statutes is amended by adding a subsection to read: § 6701. Wearing of uniforms and insignia and misrepresentation 13 14 of military service or honors. 15 16 (c) Deposit of fines. -- Notwithstanding any other provision 17 of this title or other law to the contrary, the full amount of each fine collected under this section shall be deposited into 18 the Veterans' Trust Fund under 51 Pa.C.S. § 1721 (relating to 19 20 Veterans' Trust Fund).
