3	(a) LogotypeThe department, in consultation with the
4	Office of Administration, shall design an official Commonwealth
5	logotype to be used by veteran, reservist or National Guard-
6	owned businesses, which shall include the Commonwealth Coat of
7	Arms and the words "Pennsylvania veteran-owned business,"
8	<u>"Pennsylvania reservist-owned business" or "Pennsylvania</u>
9	National Guard-owned business."
10	(b) ApplicationThe department shall develop a form upon
11	which eligible businesses may apply for the issuance and use of
12	a logotype under this section.
13	(c) EligibilityThe following apply:
14	(1) Businesses that are currently verified by the
15	Department of General Services under 62 Pa.C.S. Ch. 22
16	(relating to diverse and disadvantaged businesses) shall be
17	approved and issued a logotype under this section without
18	additional verification.
19	(2) The department shall verify the military service
20	status of business owners seeking status as a veteran-owned
21	business, reservist-owned business or National Guard-owned
22	business. The department may work with other State agencies
23	to process verification.
24	(d) NoticeThe department shall post on the department's
25	publicly accessible Internet website a notice that:
26	(1) Logotypes under this section are available to
27	<u>eligible businesses.</u>
28	(2) Includes the criteria necessary to receive the
29	logotypes and allows for access to the applications and
30	directions on how to submit the applications.

1	(e) IssuanceThe department shall issue a logotype to
2	applicants deemed eligible under subsection (c).
3	(f) AdministrationThe department may:
4	(1) Establish a nominal fee to cover the cost of
5	verification.
6	(2) Utilize money from the Veterans' Trust Fund to
7	establish the logotypes and a system for verification.
8	(g) PenaltyAn individual commits a misdemeanor of the
9	third degree if the individual fraudulently holds the individual
10	out to be a veteran, reservist or National Guard member for the
11	purpose of obtaining a logotype under this subchapter.
12	(H) DEPOSIT OF FEESNOTWITHSTANDING ANY OTHER PROVISION OF <
13	LAW, THE FULL AMOUNT OF EACH FINE COLLECTED FOR A VIOLATION OF
14	SUBSECTION (G) SHALL BE DEPOSITED INTO THE VETERANS' TRUST FUND.
15	Section 3. This act shall take effect in 60 days.
