AN ACT

1 Providing for the capital budget for fiscal year 2018-2019;  
2 itemizing public improvement projects and furniture and  
3 equipment projects leased or assisted by the Department of  
4 General Services, the Department of Conservation and Natural  
5 Resources, the Department of Environmental Protection, the  
6 Department of Transportation or the Pennsylvania Fish and  
7 Boat Commission, together with their estimated financial  
8 costs; authorizing the incurring of debt without the approval  
9 of the electors for the purpose of financing the projects to  
10 be constructed, acquired or assisted by the Department of  
11 General Services, the Department of Environmental Protection,  
12 the Department of Transportation or the Pennsylvania Fish and  
13 Boat Commission; authorizing the use of current revenue for  
14 the purpose of financing the projects to be constructed,  
15 acquired or assisted by the Department of Conservation and  
16 Natural Resources or the Department of Transportation stating  
17 the estimated useful life of the projects; and making  
18 appropriations.

19 The General Assembly of the Commonwealth of Pennsylvania  
20 hereby enacts as follows:

21 Section 1. Short title.

22 This act shall be known and may be cited as the Capital  
23 Budget Project Itemization Act of 2018-2019.

24 Section 2. Total authorizations.

25 (a) Public improvements.--The total authorization for the  
26 additional capital projects in the category of public

1 improvement projects itemized in section 3 and to be acquired or  
2 constructed by the Department of General Services, its  
3 successors or assigns, and to be financed by the incurring of  
4 debt shall be \$1,608,338,000.

5 (b) Furniture and equipment.--The total authorization for  
6 the additional capital projects in the category of public  
7 improvement projects consisting of the acquisition of original  
8 movable furniture and equipment to complete public improvement  
9 projects itemized in section 4 and to be acquired by the  
10 Department of General Services, its successors or assigns, and  
11 to be financed by the incurring of debt shall be \$3,000,000.

12 Section 3. Itemization of public improvement capital projects.

13 Additional capital projects in the category of public  
14 improvement projects to be acquired or constructed by the  
15 Department of General Services, its successors or assigns, and  
16 to be financed by the incurring of debt, are hereby itemized,  
17 together with their respective estimated financial costs, as

22	(a) Public improvements.--The Governor, Auditor General and	
23	State Treasurer are hereby authorized and directed to borrow

18 Section 18. Estimated useful life and term of debt.

19 (a) Estimated useful life.--The General Assembly states that  
20 the estimated useful life of the public improvement projects  
21 itemized in this act is as follows:

23 (2) Furniture and equipment, 10 years.

24 (b) Term of debt.--The maximum term of the debt authorized  
25 to be incurred under this act is 30 years.

26 Section 19. Appropriations.

27 (a) Public improvements.--The net proceeds of the sale of  
28 the obligations authorized in this act are hereby appropriated  
29 from the Capital Facilities Fund to the Department of General  
30 Services in the maximum amount specified in section 2(a) to be

1 used by it exclusively to defray the financial cost of the  
2 public improvement projects specifically itemized in a capital  
3 budget. After reserving or paying the expenses of the sale of  
4 the obligation, the State Treasurer shall pay to the Department  
5 of General Services the money as required and certified by it to  
6 be legally due and payable.

7 (b) Furniture and equipment.--The net proceeds of the sale  
8 of the obligations authorized in this act are hereby  
9 appropriated from the Capital Facilities Fund to the Department  
10 of General Services in the maximum amount specified in section  
11 2(b) to be used by it exclusively to defray the financial cost  
12 of the public improvement projects consisting of the acquisition  
13 of original movable furniture and equipment specifically  
14 itemized in a capital budget. After reserving or paying the

18 Section 20. Federal funds.

19 (a) Projects itemized in this act.--All money received from  
20 the Federal Government for the projects specifically itemized in  
21 this act are also hereby appropriated for those projects.

22 (b) Projects not requiring itemization.--Department of  
23 Military and Veterans Affairs construction projects which are  
24 totally federally funded and to be administered by the  
25 Department of General Services are hereby authorized.

27 Section 22. Editorial changes.

28 In editing and preparing this act for printing following the  
29 final enactment, the Legislative Reference Bureau shall insert  
30 or revise letters or numbers for projects where the letters or

1 numbers are missing or require revision. The Legislative  
2 Reference Bureau shall also revise the total monetary amounts  
3 for the total authorization, debt authorization, appropriations  
4 and department totals as necessary to agree with the total  
5 monetary amounts of the projects.

6 Section 23. Effective date.
